Subject Declaring District Personal Property Obsolete, Surplus, and Authorizing Disposition Thereof – Vehicles

Ask of the Board Approval by the Board of Education of Resolution No. 2425-0134 - Declaring District Personal Property Obsolete, Surplus, and Authorizing Disposition Thereof – Vehicles

Background & Discussion Following a routine review of department vehicles some were found to be surplus, obsolete and of no further use to the district. It is the recommendation of the Superintendent of Schools that such items be declared obsolete, surplus and/or sold, donated to a charitable organization, or disposed of in the local public dump upon compliance with the provisions of Education Code Section 17545 and 17546, respectively.

Fiscal Impact Disposition of the items listed in Exhibit “A” will reduce the cost associated with purchasing of new vehicles and the financial returns on an item that would otherwise further generate a further cost to the district for disposal.
