**ASK OF THE BOARD**

Ratification by the Board of Education of the President of the Board’s appointment of Benjamin “Sam” Davis, as the Business Community Member, to the Measures B, J, and Y Independent Citizens School Facilities Bond Oversight Committee, effective January 15, 2026, for the unexpired term ending June 30, 2027.

**BACKGROUND/DISCUSSION**

The duties of the Measures B.J.Y Committee, as defined by Board Bylaw 9131, among other duties, is to provide advice and recommendation to the District regarding the expenditure of funds for bond related projects, to actively review and report on the proper expenditure of taxpayers’ money for school construction and to take any necessary action in furtherance of its purpose including, but not limited to, receiving and reviewing copies of annual independent financial audits and deferred maintenance proposals, inspecting school facilities and grounds, receiving and reviewing cost-saving measures designed to reduce the costs of professional fees and site preparation. The Committee also shall have the option to tour sites where Bond funds are being expended, with support from the Superintendent.

**RECOMMENDATION**

I am recommending that the Board confirm my appointment of Benjamin “Sam” Davis, as the Business Community Member, to the Measures B, J, and Y Independent Citizens School Facilities Bond Oversight Committee, effective January 15, 2026, for the unexpired term ending June 30, 2027.

## EXPERIENCE

**Community Engagement Expert:** *Alameda County Office of Education, 2025–present*

- Consulted with school leaders across Oakland to engage with them on the long-term fiscal challenges confronting the Oakland Unified School District, and to gather feedback on plans to restructure central administration and reimagine the district footprint.

**School Board Trustee:** *Oakland Unified School District, 2021–2025*

- Developed policy, jointly supervised the Superintendent and General Counsel, and prioritized among myriad high-stakes issues as an elected official in the 11th largest school district in California.
- Elected Vice President of the Board for 2021 and 2022, and President for 2024.
- Led the campaign for the renewal of the College & Career for All initiative as Measure H on the November 2022 ballot, overwhelmingly passed by Oakland voters 82% to 18%, which continues to dramatically increase graduation rates for all students, from 61% in 2014 to 80% today, while shrinking opportunity gaps for multiple focal groups.
- As Chair of the Facilities Committee in 2023, collaborated with staff to develop a consensus spending plan to reallocate tens of millions of dollars in construction funds equitably to address urgent building renovation needs at Title I schools to whom promises had been broken by previous administrations, approved unanimously by the full Board.
- Wrote highly-regarded monthly newsletters updating constituents on the latest developments in the District, which were widely circulated among families, staff, and district leaders seeking reliable and unbiased information.
- Navigated multiple high-conflict and high-leverage crises, including the return to in-person learning after the pandemic, intense controversy over school closures, the occupation of a closed campus, an 8-day teacher strike, and several intense debates over structural deficits, while prioritizing progressive, responsible, and sustainable stewardship of public dollars.
- Advocated successfully in partnership with the Oakland Youth Vote Coalition at the City Council and County Board of Supervisors to win full implementation of Measure QQ, allowing 16- and 17-year-olds to vote for school board members for the first time in a large California city in the November 2024 election.
- Developed strong relationships with other local and state elected officials, represented Oakland Unified in numerous media interviews, public events, and panel discussions, and lobbied in Sacramento on behalf of the District.
