**ACTION REQUESTED**

Ratification by the Board of Education of President of Board’s reappointment of Pavan Gupta (2<sup>nd</sup> Term), and Reggie Lee (2<sup>nd</sup> Term), each having satisfactory served first term, to the Measure G Parcel Tax Independent Citizens Oversight Committee, for a term effective February 1, 2026 through January 31, 2028, respectively.

**BACKGROUND/DISCUSSION**

The duties of the Measure G Committee, as defined by Board Bylaw 9131, is to inform the public concerning the expenditure of parcel tax revenues and to review and report annually on the proper expenditure of taxpayers’ money generated by the 2009 Measure G parcel tax.

The Measure G Committee is composed of seven members, with staggered terms, appointed pursuant to membership criteria established by Board Bylaw 9131, with an individual's terms of appointment limited to a maximum of three two-year consecutive terms or the fulfillment of unexpired terms thereof.

## **RECOMMENDATION**

I, pursuant to Board Bylaw 9131, hereby reappoint avan Gupta (2nd Term), and Reggie Lee (2nd Term), each having satisfactory served first term, to the Measure G Parcel Tax Independent Citizens Oversight Committee, for a term effective February 1, 2026 through January 31, 2028, respectively.
