1) Digital Learning – Digital textbooks, Kindles and Chromebooks in the classroom will help close the opportunity gap in our schools by creating educational equity for the next generation. 1) School Districts are currently facing significant challenges: namely, the implementation of LCFF, LCAP and Common Store State Standards. With these challenges comes the potential for great improvements in student achievement. CSBA is uniquely poised to provide training and information to its member districts and boards to aid in making these changes, as CSBA has already done through webinars, fact sheets, local workshops, and information on their web site.

2) LCFF promises to unshackle boards from the myriad of rules and constraints that have hampered our efforts to meet the needs of our students. CSBA is the only organization that advocates at the state level and champions the importance of local control to the governor, the legislature, and the courts. Advocating for sound laws and policies that protect local control from special interests, as they did with AB375, should be a primary focus of CSBA at the state level.

3) Boards face the challenges of providing resources to implement the common core standards and of communicating with parents and the community who are confused and concerned about how their children will be affected by the new standards and new tests. Hands-on tools and educational support from CSBA will help districts navigate the minefield that major policy shifts bring.

Our NUSD leadership rotation has placed me in the role of Board President this year.
