ACTION REQUESTED:

Conduct Public Hearing and Adoption of Resolution No. 1112-0118 – Request to the California State Board of Education for a General of Education Code Section 52055.740 on behalf of *Manzanita Community Elementary School*, incorporated herein by reference as though fully set forth, to the California State Board of Education and authorizes the submission of same with requisite supporting documentation.

BACKGROUND:

The Quality Education Investment Act (QEIA) is the result of a settlement between Governor Schwarzenegger and the California Teachers' Association (CTA) which is aimed at boosting student achievement at low-performing schools. In May 2007 State Superintendent of Public Instruction Jack O'Connell announced that 488 low-performing schools in California were selected to receive QEIA funding. The Oakland Unified School District has 19 QEIA funded schools; four middle schools and fifteen elementary schools.

QEIA schools have demonstrated meaningful to significant growth in academic achievement over-all as a result of implementing the various strategies outlined in the QEIA program. QEIA non-compliance reported for schools in the 2010-11 school year has been determined to be correctable under the state's General Waiver process. The district, in an effort to ensure maintenance of these funds for the 2012-13 school year for specific schools, must seek a General Waiver of the State Board of Education.

The District is taking steps to further assist QEIA funded schools in meeting the compliance targets set forth under the Quality Education Investment Act. The continued provision of QEIA funding for the

2012-13 school year will likely contribute significantly to continued academic gains for designated school.

FISCAL IMPACT:

The adoption of the Request by the District and granting of the Waiver by the State Board of Education will assist the District in maintaining approximately \$2,500,000 in QEIA funding over the next two years.

The approval of this waiver request will not have a negative fiscal impact on the District.

RECOMMENDATION:

This Waiver is requesting that the Class Size Reduction Targets established for Manzanita Community School of 18.33 for 4 th grade, 16.33 for 5 th grade, and be increased to 25 students in these grade levels for the 2010-2011 school year in light of the following circumstances:
As a means of meeting both the Class Size Reduction Criteria and the educational needs of the Students in multiple QEIA schools in the Oakland Unified School district, Site and District administrators proposed the use of Highly Qualified Credentialed Teachers in a "push-in" model for core instruction for those classes that had student to teacher ratios higher that the QEIA CSR targets. Site and district administrators contacted the Northern California Technical Assistance Center and requested a review and recommendation for this proposal. The recommendation from the Northern California Technical Assistance Center was to proceed with this proposed model for reducing class sizes and progressively support the educational needs of students as the representative from the Northern California Technical Assistance Center determined this proposal to be in line with the Educational Code.
With the support of the administrative and teaching staff at Manzanita Community School the proposed model was implemented for the 2010-2011 school year.
Near the conclusion of the 2010-2011 school year, during the pre-monitoring phase, the district was notified by the Northern California Technical Assistance Center that the recommendation the center had made to Oakland Unified School District to proceed with use of Highly Qualified Credentialed Teachers in a "push-in" model for core instruction was not in line with the Educational Code for QEIA class size reduction and therefore those schools who had implemented this model would be found out of compliance for the 2010-2011 school year.
