#### **ACTION REQUESTED:**

Conduct Public Hearing and Adoption of Resolution No. 1213-0077 – Request to the California State Board of Education for a General of Education Code Section 52055.740(a) on behalf of *Claremont Middle School*, incorporated herein by reference as though fully set forth, to the California State Board of Education and authorizes the submission of same with requisite supporting documentation.

#### **BACKGROUND:**

The Quality Education Investment Act (QEIA) is the result of a settlement between Governor Schwarzenegger and the California Teachers' Association (CTA) which is aimed at boosting student achievement at low-performing schools. In May 2007 State Superintendent of Public Instruction Jack O'Connell announced that 488 low-performing schools in California were selected to receive QEIA funding. The Oakland Unified School District has 13 QEIA funded schools; four middle schools and nine elementary schools.

QEIA schools have demonstrated meaningful to significant growth in academic achievement over-all as a result of implementing the various strategies outlined in the QEIA program. QEIA non-compliance reported for schools in the 2011-12 school years have been determined to be correctable under the state's General Waiver process. The district, in an effort to ensure maintenance of these funds for the 2013-14 school years for specific schools, must seek a General Waiver of the State Board of Education.

The District is taking steps to further assist QEIA funded schools in meeting the compliance targets set forth under the Quality Education Investment Act. The continued provision of QEIA funding for the 2013-14 school years will likely contribute significantly to continued academic gains for the designated school.

#### **FISCAL IMPACT:**

The adoption of the Request by the District and granting of the Waiver by the State Board of Education will assist the District in maintaining approximately \$350,000 in QEIA funding annually.

The approval of this waiver request will not have a negative fiscal impact on the District.

For each funded school, the county superintendent of schools for the county in which the school is located shall annually review the school and its data to determine if the school has met all of the following program requirements by the school by the end of the third full year of funding:

(3) Ensure that each teacher in the school, including intern teachers, shall be highly qualified in accordance with the federal No Child Left Behind Act of 2001 (20 U.S.C. Sec. 6301 et seq.).

# **Outcome Rationale:**

QEIA requires that all teachers on a campus meet HQT requirements. The Severely Handicapped-Special Day Class (SH-SDC) teacher at Claremont Middle School was wrongly listed as the Adaptive PE teacher of record at Claremont Middle School in 2011-12. The SDC-SH teacher would not have been HQT-compliant to teach Adaptive PE. The District has acquired confirmation from the Programs for Exceptional Children department, which oversees staffing and management of the District's Special Education program, that the SH-SDC teacher **was not** the Adaptive PE teacher in 2011-12.

### **Student Population:**

Oakland USD has a student population of 38,040 (in 2011-12) and is located in an Urban Setting *in Alameda* County. Claremont Middle School had a student population of 460 in 2011-12.
