Dear Senator Feinstein:

This communication is to advise you that the City of Oakland, CA Board of Education at its Regular Meeting of February 27, 2013 voted to oppose the Federal Sequestration being brought on by the enacted Budget Control Act of 2011 and Taxpayer Relief Act of 2012, effective March 1, 2013.

The Oakland Public Schools student population, with these Acts in effect, will lose between \$5-\$8 million in Titles I, II and III federal education funding. A hit that we cannot afford. Also federal funding reductions to the City of Oakland's Head Start Program, to law enforcement and public safety, to child care, and to public health service providers, among others, who are partners engaged with us as a "Full Service Community School District" will be very disruptive to the specific ancillary programs that help keep our children safe at home, fed, healthy, in school, and academically on track.

We know that you oppose all or most of all of the devastating cuts being brought on by these Acts. We ask you to use all of the ingenuity at your disposal to persuade a majority of your Congressional colleagues to join with you and the President in mitigating the devastating impact that these Acts, if not reasonably modified, will have on the children of the City of Oakland, the State of California and the nation.
