# **ACTION REQUESTED**

Approval by the Board of Education of Resolution No. 1314-1143, Rescinding of Hiring Freeze – Classified Represented Positions—School Sites and Central Office Departments.

### DISCUSSION

The Board of Education, on January 29, 2014, as part of its ongoing maintenance of the District's fiscal solvency, approved Resolution No. 1314-0099, imposing a temporary hiring freeze for all classified represented employee positions for school sites and central office departments.

The District budget for Fiscal Year 2014-2015 provides sufficient funding for the planned staffing of classified represented employee positions for school sites and central office departments for the upcoming school year. Accordingly, there is an immediate need to staff said school site and central office department positions pursuant to the management plan for school operations on or before July 1, 2014, and thereafter.

In order to do so, it is recommended that Resolution No. 1314-0099 be vacated.

## **FISCAL IMPACT**

Staffing for such services is part of the approved District budget for the 2014-2015 Fiscal Year. Lifting of the referenced hiring freeze will not negatively impact the District's budget.
