In Support of Wages Equal to or Exceeding Community Wage Standards

WHEREAS, the District currently has categories of unrepresented employees who are paid at or higher than the California minimum wage;

WHEREAS, Effective March 2, 2015, the community standard for minimum wages will be set at a rate higher than the minimum wage set by California;

WHEREAS, the Oakland Unified School District believes all employees should be paid a wage that reflects the cost of living in Oakland, and for that reason supports the spirit of Oakland's higher wage standard:

NOW THEREFORE, BE IT RESOLVED THAT, the Board of Education of the Oakland Unified School District does hereby determine that the hourly rate for Substitute Food Service Assistants and Substitute Aides Special Education be increased to \$12.25 per hour;

NOW THEREFORE, BE IT RESOLVED THAT, the Board of Education of the Oakland Unified School District does hereby determine that the hourly rate for Substitute Custodians be increased to \$12.61 per hour.
