RESOLUTION OF THE BOARD OF EDUCATION OF THE OAKLAND UNIFIED SCHOOL DISTRICT Resolution No. 1415-1134

Elimination of Special Education Paraprofessional Job Descriptions

WHEREAS, in Spring 2012, the Board directed the development of a Special Education Strategic Plan aligned to the District's Strategic Plan;

WHEREAS, from Fall 2012 through June 2013, various stakeholders were engaged to create the framework for Special Education's Strategic Plan;

WHEREAS, in September 2013 the Special Education Strategic Plan Steering Committee and workgroups met to develop the Special Education Strategic Plan goals based on the gathered input from stakeholders;

WHEREAS, in May 2014, the Board adopted the Special Education Strategic Plan. The goals of the plan included improving performance for students with Individual Education Plans (IEPs), addressing social emotional learning needs of all students, establishing effective inclusive models for students with IEPs, establishing accountability for quality by using data and engaging with the community, hiring and retaining highly qualified staff, and improving compliance. The plan also explicitly noted a need to develop services to serve students within OUSD rather than non-public schools and agencies;

WHEREAS, to achieve the goals of the Special Education Strategic Plan, job responsibilities, training, and professional development opportunities for classified roles needed to be expanded to create efficiencies, reduce external contracts, and improve services for students;

WHEREAS, for Fiscal Year 2015-2016, based on the fiscal need to increase efficiencies and reduce external contracts and the necessary shifts in work to carry out the goals of the Special Education Strategic Plan, it is necessary for the District to streamline, reorganize, reduce and/or eliminate positions, in whole or in part; and

WHEREAS, at the April 22, 2015 meeting of the Board of Education, the Board approved two new job descriptions for Programs for Exception Children, namely Paraeducator and Instructional Support Specialist; and

WHEREAS, effective September 15, 2015, the four existing job descriptions, namely Instructional Assistant – Special Education; Aide – Special Education; Intervention Specialist; and Custodial Health Aide are no longer necessary;

NOW, THEREFORE, BE IT RESOLVED that the Board of Education eliminates the following four existing job descriptions, namely Instructional Assistant – Special Education; Aide – Special Education; Intervention Specialist; and Custodial Health Aide effective September 15, 2015.
