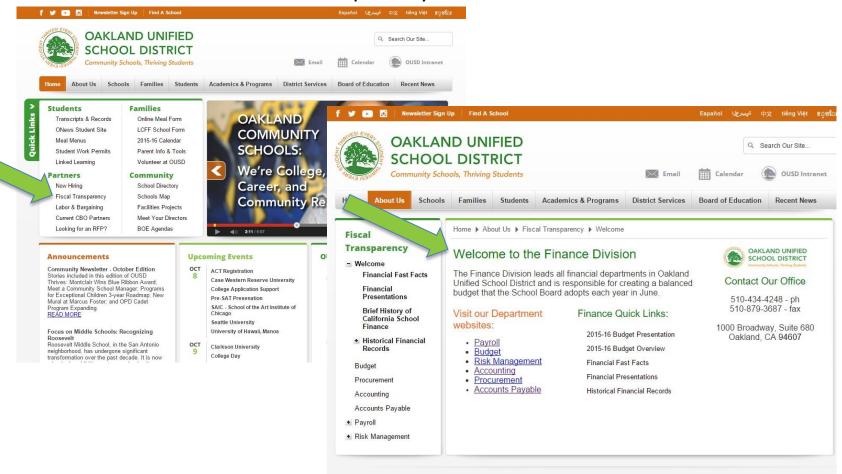

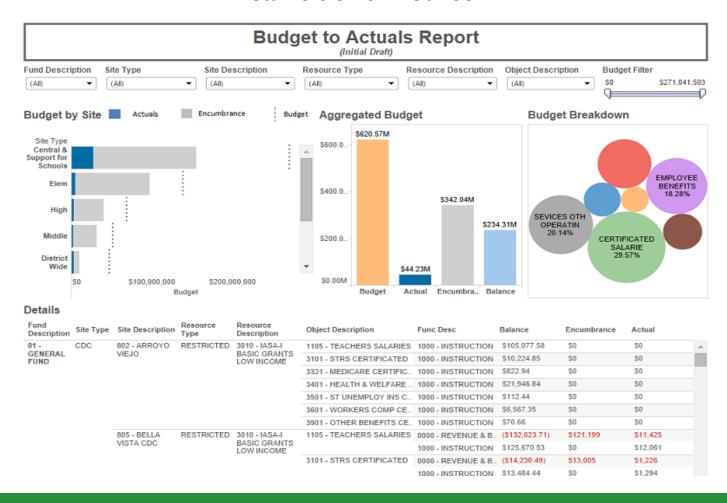






2015-16 Budget Available on Website for Filtering & Easy View

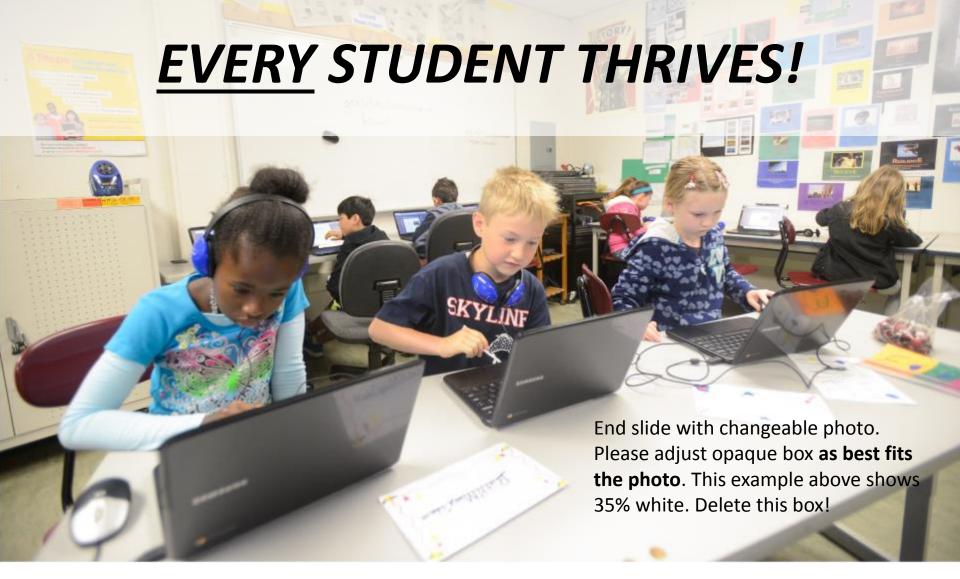
