**Subject** **Authorization to Declare Property Obsolete and Surplus**

**Action Requested** Approval by the Board of Education of Resolution No. 1516-0080  
Authorization to Declare Obsolete Surplus Property and Authorizing Sale.

**Background** Following a routine review of vehicles in the Police Services department, some vehicles were found to be surplus, obsolete and of no further use to the District. It is the recommendation of the Superintendent of Schools that such items be declared surplus and sold in accordance with Education Code sections 17545 and 17546, respectively.

**Recommendation** Approval by the Board of Education of Resolution No. 1516-0080  
Authorization to Declare Obsolete Vehicles Surplus Property and Authorizing Sale.

**Fiscal Impact** Sale of the items listed in Exhibit "A" will reduce the cost associated with purchasing a new vehicle and the financial returns on an item that would otherwise generate a cost to the district for disposal.
