Action Requested Approval by the Board of Education of Resolution No. 1516-0095 -

Background Following a routine review of equipment in the Food Services department, some equipment were found to be surplus, obsolete and of no further use to the District. It is the recommendation of the Superintendent of Schools that such items be declared surplus and sold in accordance with Education Code sections 17545 and 17546, respectively.

Fiscal Impact Sale of the items listed in Exhibit "A" will reduce the cost associated with purchasing new equipment and the financial returns on an item that would otherwise generate a cost to the district for disposal.
