Background and Discussion	The Governing Board previously declared the policy vehicles identified in this Resolution as obsolete and/or surplus and authorized a public sale of such vehicles. Education Code 17542 also allows the transfer of surplus or obsolete property to a governmental agency without public bid upon approval of the County Superintendent of Schools. It is in the District's best interests to transfer the vehicles to the Oakland Police Department (OPD) in furtherance of a mutual beneficial collaboration in which OPD provides equipment and services to the District at no cost. The costs of stripping the vehicles for public sale and engaging in the costs of a public sale would not provide as much value to the District.

RESOLUTION OF THE BOARD OF EDUCATION OF THE OAKLAND UNIFIED SCHOOL DISTRICT RESOLUTION NO. 1516-0200

Transfer of District Obsolete or Surplus Property to Governmental Agency – City of Oakland - Police Department

WHEREAS, the Board of Education of the Oakland Unified School District previously passed Resolution Numbers 1415-0145, 1415-0171, and 1516-0133 declaring certain vehicles as obsolete and/or surplus and authorizing public sale of such vehicles;

WHEREAS, under Education Code section 17542 the District may dispose of surplus personal property to another governmental agency without public bid upon approval of the County Superintendent of Schools;

WHEREAS, as reflected in the attached letter, the County Superintendent of Schools approved a proposed transfer of the District vehicles listed in Exhibit "A" to the Oakland Police Department (OPD) to further an ongoing collaboration between OPD and the Oakland Schools Police Department (OSPD) in which OPD provides the following services and equipment use at no cost to the District:

- Access to OPD's Field Base Reporting System (FBR) at no cost to OSPD (Estimated cost an excess of \$200k)
- Access to OPD's Computer Aided Dispatch System (CAD) at no cost to OSPD (Estimated cost an excess of \$500k)
- Access to OPD's Database and Secured Network
- Installation of all software and hardware required to operate through the secure network at no cost to OSPD (Estimated cost an excess of \$8k)
- Dispatch services and training, no cost to OSPD
- Handheld and mobile radio upgrades and maintenance at no cost to OSPD (Estimated cost an excess of \$50k)
- Unique radio profile with a dedicated channel for OSPD at no cost to OSPD (Estimated cost an excess of \$12k yearly)
- OPD training courses at no cost to OSPD
- Continued Professional Training (CPT) for all OSPD sworn personnel at no cost to OSPD (Cost of \$800 per officer, every 12-18 months)

WHEREAS, the estimated cost to OSPD to independently establish these systems would exceed \$770,000 dollars which does not include maintenance, upgrades, equipment and personnel.

WHEREAS, the vehicles on Exhibit A have been declared obsolete and/or surplus and are of no value to the District. Although the vehicle transfer is not intended as a direct exchange for these systems, it is a cost offset to further the mutually beneficial collaboration between the departments. Additionally, the ongoing costs to insure,

maintain, store, and safeguard such vehicles create a net liability and the costs to strip the vehicles and engage in a public sale create a further cost to the District.

NOW THEREFORE, BE IT RESOLVED the Board of Education of the Oakland Unified School District finds that a transfer of the vehicles listed on Exhibit A to Oakland Police Department is in the best interests of the District and hereby amends Resolutions 1415-0145, 1415-0171, and 1516-0133 to authorize and direct such transfer in accordance with Education 17542.
