ACTION REQUESTED

Approval by the Board of Education of Resolution No. 1516-0205, Rescinding of Hiring Freeze – Classified Central Office Positions.

DISCUSSION

The Board of Education, on February 10, 2016, as part of its ongoing maintenance of the District's fiscal solvency, approved Resolution No. 1516-0146, imposing a temporary hiring freeze for all classified central office positions.

The proposed District budget for Fiscal Year 2016-2017 provides sufficient funding for the planned staffing of classified central office positions for the upcoming school year. Accordingly, there is an immediate need to staff said central office department positions pursuant to the management plan for school operations on May 12, 2016, and thereafter.

In order to do so, it is recommended that Resolution No. 1516-0146 be vacated.

FISCAL IMPACT

Staffing for such services is part of the proposed District budget for the 2016-2017 Fiscal Year. Lifting of the referenced hiring freeze will not negatively impact the District's budget.
