Total Williams Complaints

- During the 2015-16 school year, the district has received a total of 43 Williams Complaints; 32 more than 2014-15
- For the January 2016 Quarterly Report, we received a total of 14 complaints, which have all been resolved.
- For the April 2016 Quarterly Report, we received a total of 9 complaints; three (3) are still pending.



Jan – April 2016 Williams Complaints

- Textbooks & Instructional Materials – **1** complaint
- Teacher Vacancy or Misassignment – **4** complaints
- Facilities Conditions – **18** complaints
- CAHSEE – *Not Applicable.*
- In October 2015, Governor Brown signed SB 172 which suspends passage of the California High School Exit Exam as a high school graduation requirement through the 2017-18 school year.
- 20 out of 23 complaints have been resolved.



Specific Complaint Areas

We have received an increase in complaints about a lack of air conditioning and excessive heat in classrooms.

- We have received 4 complaints about Teacher Vacancies: two 5th grade teachers at New Highland, a Spanish Teacher at Fremont and an Art Teacher at Madison Park High School.

- We have received 18 Facilities complaints. Some were regarding excessive heat and no air conditioning at Laurel, PLACE @ Prescott, Bella Vista, and Manzanita SEED. Some concerns were about mice at Roots and New Highland. Also, an on-going concern regarding flooding on the Kindergarten yard at Manzanita SEED during rainy weather. Plan to repair during the summer.

- Buildings & Grounds and Custodial Services staff have been very responsive.
