(A)(1) Arrest by OSPD on OUSD School Sites for School Related Offenses

- Battery on School Grounds, Black, Male, 11 (Montera)
 - Suspect was throwing pencils at the victim. Victim confronted the suspect at which point the male suspect punched the female victim on the chest causing her to fall to the floor in pain.
- Robbery/ Conspiracy, Hispanic, Male, 14 (Skyline)
 - Officers responded to the hospital on a report of a student who was assaulted on campus. It was then determined that the victim was robbed by 5-6 suspects after being struck on the face causing serious injury. Victim was able to identify one of the suspects who was ultimately arrested for the crime.
- Domestic Battery, Hispanic, Female, 16 (Madison)
 - Suspect attacked her ex-boyfriend.
- Assault with Deadly Weapon (hands/feet), Black, Male, 16 (Fremont)
 - Suspect attacked an adult victim who was standing on the sidewalk.









(A)(1) Arrest by OSPD on OUSD School Sites for School Related Offenses



Posses Weapon on School Grounds, Black, Male, 14 (Skyline)

 Suspect was being searched by admin staff for suspicion of having marijuana on his person. As the staff searched the suspect's backpack, they observed what appeared to be a semi-automatic pistol. Police recovered the pistol and determined the weapon was a less than lethal gas gun capable of causing serious injury.

Attempt Robbery, Black, Male, 16 (Skyline)

 Suspect attempted to rob the victim while the victim was in the bathroom. The victim did not have any items of value on his person. Suspect then threw the victim on the floor and began to strike the victim on the head with his fist multiple times.

Theft, Black, Male, 17 (Dewey)

 Suspect was searched by admin staff on suspicion that he may have stolen a laptop computer. Upon searching the suspect, staff located the stolen laptop computer.











(A)(2) Arrest by OSPD on OUSD School Sites for Non-School Related Offenses

Rape, Black, Male, 14 (Claremont)

OPD Special Victims Unit advised OSPD that the suspect had an active arrest warrant for rape.
 Officer responded to the site and served the warrant without incident.

Robbery/ Failure to Appear, Black Male, 14 (Westlake)

 Officer responded on a report of a stay away order violation. Officer conducted a file check of the suspect which revealed an active arrest warrant for robbery and failure to appear to court.

Battery on Bus Operator, Black, Male, 15 (Skyline)

 Alameda County Sheriff's Office Deputies contacted OSPD and advised officers that the suspect had an arrest warrant for assaulting a bus operator. Deputies, School Staff, and OSPD coordinated the arrest without incident.

Burglary/ Auto-Theft, Black, Male, 17 (Oakland High)

 Daily City Police advised OSPD that the suspect had an active arrest warrant for committing a burglary and auto-theft in Daily City. DCPD and OSPD coordinated the arrest with school staff and the suspect was taken into custody without incident.

Oakland Technical High School

- "Stand by and Preserve the Peace" (51 Calls for Service)- Provided a presence in order to prevent disturbances/ altercations.
- "Disturbance- Juveniles" (25 Calls for Service)- Officers responded to incidents involving juveniles causing some sort of disturbance in or around the perimeter of the school site.
- "Walk Through" (13 Calls for Service)- Were conducted in order to provide additional support to the site when there was concern that required more than the daily check-in of the police officer.
- "Battery" (8 Calls for Service)- Battery reports were taken at the request of the victims who requested charges be filed against the assailant.











McClymonds High School

- "Stand by and Preserve the Peace" (39 Calls for Service)- Provided a presence in order to prevent disturbances/ altercations.
- "Walk Through" (19 Calls for Service)- Were conducted in order to provide additional support to the site when there was concern that required more than the daily check-in of the police officer.
- "Disturbance- Juveniles" (15 Calls for Service)- Officers responded to incidents involving juveniles causing some sort of disturbance in or around the perimeter of the school site.
- "Fights" (9 Calls for Service)- Police responded to incidents where additional support was needed to assist staff.









Skyline High School

- "Stand by and Preserve the Peace" (26 Calls for Service) Provided a presence in order to prevent disturbances/ altercations.
- "Battery" (12 Calls for Service)- Battery reports were taken at the request of the victims who requested charges be filed against the assailant.
- "Disturbance- Juveniles" (9 Calls for Service)- Officers responded to incidents involving juveniles causing some sort of disturbance in or around the perimeter of the school site.
- "Drug Dealing" (8 Calls for Service)- Police responded to incidents where subjects were found in possession of drugs with the suspicion that the subjects intended to sale/ distribute/ trade the drugs.













Fremont High School

- "Stand by and Preserve the Peace" (14 Calls for Service) Provided a presence in order to prevent disturbances/ altercations.
- "Disturbance- Juveniles" (9 Calls for Service)- Officers responded to incidents involving juveniles causing some sort of disturbance in or around the perimeter of the school site.
- "911 Hang Up" (8 Calls for Service)- Officers were dispatched to investigate the nature of the emergency call and the reason for the disconnection.
- "Mentally III" (7 Calls for Service)- Officers responded to evaluate subjects in order to determine if the subjects met the criteria for an involuntary psychiatric hold.

- 3. Inappropriate comment made to student. Non Sustained.
- 4. Rude comment by an SSO to a parent. Non Sustained.
- 5. Excessive Use of Force and Failing to Report. Sustained both Counts.
- 6. Excessive Use of Force by two SSO's. Unfounded.













Use of Force Policy

School Security Officers (SSO) will not have any physical contact with any students due to the following reasons:

- Defiance
- Administrative Policy/Rule Violation
- Where the student isn't a physical threat/harm to students and staff or themselves.



Executive Summary

- The 20th day enrollment for 2016-17 is **36,568**:
 - √ 35,100 Non Special Day Class (SDC)
 - **√ 1,468** SDC
- The enrollment is 872 lower than projected for 2016-17 and 413 lower than 20th day last year (2015-16).
- Staff is currently collecting data from families to determine why we didn't meet projections and even more, why we are lower that last year. Some possible reasons:
 - ✓ Charter school attendance grew by approximately 1,000 students, at mainly newly opened or expanded sites.
 - ✓ The possibility that families in previously affordable areas (East and West Oakland) are being pushed out financially.
 - ✓ Current median rent for 2-bedrooms in Oakland is \$3,247. (source: Zillow Rental Database)


