**PLEASE TAKE NOTICE THAT ON THURSDAY,
OCTOBER 13, 2016,** at a Regular Meeting of the
Governing Board ("Board") of the Oakland Uni-
fied School District, the Board will hold a pub-
lic hearing on the District's Sufficiency of Text-
books and Instructional Materials—School
Year 2016-2017.

The public hearing will be held, October 13,
2016, at 6:00 p.m., or as soon thereafter, as the
matter may be heard in The Great Room,
LaEscuelita Education Center, 1050 2nd Ave-
nue, Oakland, CA 94606-2291.

California Education Code Section 60119 re-
quires that the Board hold a public hearing,
within the first eight weeks of school, to deter-
mine for each pupil the sufficiency of text-
books or instructional materials or both,

- ◆ aligned to the content standards adopted pursuant to Education Code Sections 60605 or 60605.8 in each of the following subjects, as appropriate, that are consistent with the content and cycles of the curriculum framework adopted by the state board [of education] in:
 - ◆ (i) Mathematics.
 - ◆ (ii) Science.
 - ◆ (iii) History-social science.
 - ◆ (iv) English language arts, including the English language development component of an adopted program; and
- ◆ consistent with the content and cycles of the curriculum frameworks adopted by the state board [of education] for foreign language or health course(s).
- ◆ And sufficiency of laboratory science equipment ... applicable to science laboratory courses offered in grades 9 to 12, inclusive.
