SUBJECT: Reestablishment /Reopening of Fremont High School

ACTION REQUESTED

Approval by the Board of Education of the reestablishment and reopening of Fremont High School, a 9-12 grade school, effective School Year 2012-2013, and authorizing the filing of the appropriate CDS code application, and other related documents, if any, with the California Department of Education to effect the foregoing authorized action.

BACKGROUND

In 2003, the Oakland Unified School District, through a process of engaging community and school stakeholders, designed three new small schools to serve students that historically attended the Fremont High School. At that time, the school served approximately 1250 students in grades 9-12. The intent of the new small high schools, each serving approximately 250 students, was to create more personalized learning environments with thematically based curriculum that would support increasing student achievement and increased graduation rates. During the 2003 - 2005 school years, the district established the following school, co-located at what became know as the Fremont Federation of Schools.

- College Prep and Architecture Academy
- Mandela High School
- Media College Prep Academy
- > Paul Robeson Visual and Performing Arts (Closed June 2010)
- Youth Empowerment School (Y.E.S.) Moved to King Estates Campus after 1st year; Closed June 2011
- > Fremont In Transition (FIT) Temporary; Phased Out after 2nd year

Over the course of previous years the over-all enrollment among the three remaining small schools has declined. As a result, the schools have needed to be subsidized financially beyond the standard per pupil allocation.

DISCUSSION

Reestablishment and Reopening of Fremont High School, as a 9-12 grade school.

FISCAL IMPACT

Staff believes that the reestablishment and reopening of Fremont High School will allow the District to establish a rigorous "A-G" academic program for the pupils in the school's attendance area and to reduce the need for an additional subsidy above and beyond the standard per pupil allocation for the Fremont Federation of Schools, by 100%

RECOMMENDATION

Approval by the Board of Education of the reestablishment and reopening of Fremont High School, a 9-12 grade school, effective School Year 2012-2013, and authorizing the filing of the appropriate CDS code application, and other related documents, if any, with the California Department of Education to effect the foregoing authorized action.
