Amendment of Board Policy – Students – BP 5116 – School Attendance Boundaries – Effective July 1, 2013

WHEREAS, the Oakland Unified School District is creating a great public school system with high standards of teaching and learning for every student and high standards of service to our schools with a recommitment to our shared values of equity, achievement, and accountability; and

WHEREAS, a core strategy of Oakland Unified School District is the management of a portfolio of schools that will provide a diverse portfolio of high quality schools for students and families both within neighborhoods and district-wide; and

WHEREAS, the Board of 'Education on October 26, 2011 voted to close Lakeview Elementary School, effective June 30, 2012; and

WHEREAS, attendance area boundary changes necessary to ensure that all residences in the attendance areas of those closing schools are provided an attendance area designation for enrollment purposes, were approved on January 11, 2012 affecting Cleveland Elementary, Crocker Elementary, Lincoln Elementary and Piedmont Elementary; and

WHEREAS, kindergarten oversubscription occurred during the 2012-13 Enrollment Period in the Crocker Highlands Elementary attendance area that is likely to be chronic and ongoing; and

WHEREAS, staff has contemplated additional enrollment data, demographic data, geographic boundaries and logical street patterns, safety and transportation, density of school-age children, capacity of facilities, community input, educational programs; and

WHEREAS, staff conducted community input engagements regarding the proposed boundary changes; developed a preliminary boundary change proposal; held a Board of Education Public First Reading re: proposed boundary changes to remedy the chronic oversubscription of Crocker Highlands Elementary School on December 12, 2012; and developed final recommended attendance boundary changes; and

WHEREAS, staff recommendations include the adjustment of the following attendance areas

- 1. Cleveland Elementary
- 2. Crocker Elementary

effective July 1, 2013,

NOW, THEREFORE, BE IT RESOLVED THAT, upon the recommendation of the Superintendent of Schools, the Board hereby Amends Board Policy - Students - BP 5116 -School Attendance Boundaries, effective July 1, 2013, reducing the current Crocker Highlands Elementary and expanding the Cleveland Elementary school attendance boundaries. respectively, as reflected on the map and list of affected addresses included herein as Proposal version 2; and

BE IT FURTHER RESOLVED that effective January 9, 2013 pupils and parents residing within the Cleveland Elementary and Crocker Highlands Elementary School Attendance Boundary areas shall be afforded the neighborhood priority for school choice, pursuant to the district's Open Enrollment policies, within the new attendance boundary for School Year 2013-14; and

BE IT FURTHER RESOLVED that the Superintendent of Schools or his designee is authorized to take any and all action, save an action required of the Governing Board by law, regulation or Board Policy, to effectuate the foregoing.
