Background:

(A one paragraph explanation of why the consultant's services are needed.)

The OUSD Human Resources department will engage with contractor Nathan Pellegrin to construct a historical, annualized IFAS database that will improve HR's ability to analyze longitudinal data. Currently we have no data evidence on which to base recruitment strategies. We are not able to reliably calculate retention rates to determine why and when teachers leave. This piece of work will go a long way toward supporting the development of data-driven recruitment and retention strategies. This database, which will receive nightly extracts from IFAS, will allow HR to access its data in a way that is not currently possible. The contractor will work closely with HR to confirm business rules for data transformation, and will write code to transform the data into a format more conducive to analysis. He will also work with Technology Services to set up automatic extracts that will happen on a daily basis so that current data is always available for reporting and analysis.
