Oakland Unified School District coordinates a variety of programs using a variety of funding sources to meet the needs of American Indian/Alaska Native Students. In order to meet their language and cultural needs, the district provides extended day and after school opportunities funded by the School Improvement and After School Grants. In addition, Title I and general-purpose funds are utilized to provide parent education workshops/outreach and early childhood education services. Other supports also include STEM Corridor at some school sites that give students a range of learning opportunities in science, technology, engineering, and math. School sites provide STEM Academies, science labs, and STEM field trips to companies such as Pixar, Facebook, and Expression College of Digital Arts. Overall OUSD coordinates program to meet the American Indian/Alaska Native Student and family needs through the use of general-purpose funds, After School Program Grants, School Improvement Grants, Bechtel Science grants, and Title I.
