WHEREAS – Ms. Park has consistently modeled and supported openness to new ideas and the commitment to lifelong learning, generously supporting her colleagues by leading implementations, learning from—as well as sharing—her own ideas, work, and videotapes of her teaching for their information and assistance;

WHEREAS —Ms. Park having been selected as one of two OUSD teachers of the year, then selected as one of two Alameda County Teachers of the Year, and having now been honored as one of only five California Teachers of the year, exemplifies the remarkable attributes not only of excellent teachers but also the particular skill, passion, creativity and vision required to serve the children of OUSD,
