ACTION REQUESTED

Approval by the Board of Education of Resolution No. 1617-0104 - Application for Provisional Internship Permits - California Commission on Teacher Credentialing - on behalf of the following employees for School Year 2016-2017:

- 1. Christell Grace, K-5th Grade SDC Mild/Moderate, Markham Elementary School;
- 2. Urina Kim, 9-12th Grade Chemistry, Skyline High School;
- 3. Shana Prince, 9-12th Grade Special Education, Mild/Moderate, Castlemont High School;
- 4. Michael Thomas, 6-8th Grade, Special Education, Moderate/Severe, Claremont Middle School.

BACKGROUND

According to Title 5 Sections 80021-80021.1, the Provisional Internship Permit (PIP) was created in response to the phasing out of emergency permits and became effective on July 1, 2005. It allows an employing agency to hire an individual who has not yet met the subject matter competence requirement needed to enter an internship program. Prior to requesting a PIP, the employing agency must verify that a diligent search has been made, and a fully credentialed teacher cannot be found.

The PIP is only available at the request of an employing agency. Individuals may not apply directly to the Commission for this document. Holders of the PIP are restricted to service with the employing agency requesting the permit. An employing agency is defined as a California public school district, county office of education, non-public school, charter school, or statewide agency.

The PIP is available in the areas of Multiple Subject, Single Subject, and Education Specialist. Individuals who were issued four or fewer emergency permits may be issued one PIP as long as the employer requirements have been met. Individuals who were issued five emergency permits do not qualify for the PIP.

DISCUSSION

The Board of Education, exercising the power of the Governing Board, may approve an application seeking a Provisional Internship Permit from the Commission on Teacher Credentialing, as may be necessary for certain certificated employees of the District so they may work in the District for the 2016-2017 school year, as follows:

The current request for the 2016-2017 school year, a Provisional Internship Permit is being sought for the following employees:

- 1. Christell Grace, K-5th Grade SDC Mild/Moderate, Markham Elementary School;
- 2. Urina Kim, 9-12th Grade Chemistry, Skyline High School;

- 3. Shana Prince, 9-12th Grade Special Education, Mild/Moderate, Castlemont High School;
- 4. Michael Thomas, 6-8th Grade, Special Education, Moderate/Severe, Claremont Middle School,

Christell Grace graduated from Mississippi State University with a Bachelor's in Psychology and Social Work. The Provisional Internship Permit will allow her time to complete the CSET Exams and the requirements for an Education Specialist: Mild/Moderate teaching credential.

Urina Kim graduated from the University of California, Berkeley with a Bachelor's in Nutritional Sciences. The Provisional Internship Permit will allow her time to complete the CSET Exams and the requirements for a Single Subject: Science: Chemistry teaching credential.

Shana Prince graduated from the Oklahoma City University with a Bachelor's in English. The Provisional Internship Permit will allow her time to complete the CSET Exams and the requirements for an Education Specialist Mild/Moderate teaching credential.

Michael Thomas graduated from CSU, East Bay with a Bachelor's in Liberal Studies. The Provisional Internship Permit will allow him time to complete the CSET Exams and the requirements for an Education Specialist Mild/Moderate teaching credential.
