We were also instrumental in helping Urban Promise Academy secure a drum instructor and the master schedule was redesigned to allow all students to experience dance and drum instruction during the school year. True collaboration of the arts and education! Additionally, through our fundraising efforts for the program, we worked with many local artists and provided them an opportunity to showcase and sell their work, as well as supported local art galleries in Oakland. I am also a Board Member of the Chicana/Latina Foundation, an organization that provides scholarships, Leadership Institutes and support for Latina's attending college at every level.
