The parts of the program were not implemented as this was a planning year and the administrator who held the vision did not finish the year.

The money will be used to continue to support the planning of the pathways, supporting the Engineering pathway and the building of the new pathway. Also, in support of our special populations (Girls, Yemen students etc.).

The funds will also be used to support our internship programs.

\$5600 for internships with Faith Network- This program gave opportunities the ECCO Program did not offer and the schools have been asked to contribute this year and we were not asked to contribute at this level previously.

\$8000 for the district internship program- we were not aware that we would have to pay for this opportunity. This gives us opportunities to provide more internships for our students which supports our pathway work. \$7000 Lexia-Reading Intervention blended learning program- Being that literacy is a focus area this program supports in filling existing gaps in 5 language in order to be able to access grade level materials.

\$1000 Intervention materials- materials to address students needs social emotional and academic ex. ADHD all students would benefit from the teachers having these tools to address academic and behavior challenges.

\$1500 Summer Credit Recovery- We are working to increase our on-track to graduation rate. District's credit recovery only provides for 12th graders offering credit recovery for additional students of diverse grade levels would allow for more of our students to be on-track to graduate on-time;.Targeting 9-11th.

The total ask is \$23,100.00
