BACKGROUND:

As per Education Code Section 35186, the Superintendent or designee shall report summarized data on the nature and resolution of all Williams Uniform Complaints on a quarterly basis to the Governing Board and the County Superintendent of Schools. The report shall include the number of complaints by general subject area

with the number of resolved and unresolved complaints.

DISCUSSION:

In 2015-16, the district received a total of ninety-eight (98) Williams Uniform

Complaints.

In 2016-17, at end of April 2017, the district had received a total of twenty-three (23) complaints comprising of three (3) complaints regarding Textbooks & Instructional Materials, five (5) complaints regarding Teacher Vacancies and fifteen (15) complaints regarding Facilities conditions. All current Williams Uniform Complaints

have been resolved.

As of June 2017, we have received an additional nine (9) complaints which are pending. We will provide a final end-of-year update in the July 2017 report. Thus, year- to-date for 2016-17, we have received (32) Williams complaints, which is a difference of sixty-six (66) complaints when compared to 2015-16.
