Memorandum of Understanding
between
East Bay Asian Youth Center

regarding the
**Transfer of Funds to Support the Construction of an Artificial Turf
Football Field at the Elmhurst Campus.**

1. Purpose

This Memorandum of Understanding (MOU) describes the responsibilities and obligations of the Oakland Unified School District Division of Facilities Planning & Management (OUSDFPM) and the East Bay Asian Youth Center (EBAYC), a tax-exempt non-profit California corporation, regarding the transfer of funds to support the construction of an artificial turf football field at the Elmhurst Campus.

2. Term

September 1, 2015 to December 31, 2016


3. Obligations of OUSDFPM


- 3.1 Provide EBAYC copies of architectural renderings and contractor's total cost estimates for football field construction.
- 3.2 Provide EBAYC copies of all paid invoices for football field construction.
- 3.3 Provide EBAYC a certificate of project completion.
- 3.4 Provide EBAYC color photographs depicting the condition of the Elmhurst field "before" and "after" project construction.
- 3.5 Participate with EBAYC, Local Initiatives Support Corporation, and the Oakland Raiders to organize and host a public grand opening of the completed football field.

4. Obligations of EBAYC

- 4.1 Receive and manage the NFL/LISC Grassroots Program grant award in the amount of \$200,000 to be used solely for the construction of a new artificial turf football field at the Elmhurst campus.
- 4.2 Transfer \$200,000 to OUSDFPM upon compliance of stated obligations.
- 4.3 Participate with OUSDFPM, Local Initiatives Support Corporation, and the Oakland Raiders to organize and host a public grand opening of the completed football field.


