BP 0420.1	School-Based Program Coordination	School-Based Program Coordination was effectively eliminated by the local control funding formula (LCFF)
BP 0420.3	School-Based Student Motivation and Maintenance Program	The program was repealed by new law (AB 825 – categorical reform)
BP 0420.5	School-Based Decision-Making	Policy unnecessary and redundant with other policies that establish site decision-making groups
BP 0520	Intervention for Underperforming Schools	Policy no longer necessary since no new planning grants are being awarded for the Immediate Intervention/ Underperforming Schools Program
BP 0520.1	High Priority Schools Grant Program	State is no longer funding improvement efforts for new cohorts of schools through the High Priority Schools Grant Program. New law (SB 70) deletes this program from the list of categorical programs subject to Tier 3 flexibility.
BP 0530	Awards for School Performance	State is no longer funding the Governor's Performance Award Program.
