Welcome to the start of another year of robust leadership for the Local Control and Accountability Plan. After the lessons of last year; parent, students, and community partners are readier than ever to help the LCAP become our engine for equitable and transparent budgeting in OUSD.

As we begin our work this year, we must first review the outcomes from the visioning done by LCAP members and partners this August. This visioning was guided by your feedback in committee and community meetings last school year and by careful consideration of current district challenges and priorities.

In 2017-18, the LCAP process will focus on providing strong school site level snapshots and analyses that can show the connection between:

- How central and site resources are showing up at each school for each of the LCAP goals
- How resources and strategies link to the specific student populations and to the targeted needs that the school is supporting,
- Retention rates for school staff,
- and the student outcomes of the school.

This choice of focus for 2017-18 by the LCAP PSAC and its related committees will provide important baseline information for the Blueprint for Quality Schools process underway in OUSD so that the overall community can make informed recommendations about the types of schools and programs that we need in our district.
