OUSD is authorized by Government Code Section 53060 to contract for the furnishing of special services and advice in financial, economic, accounting, engineering, legal, and administrative matters with persons specially trained, experienced, and competent to perform such services. - Compensation: OUSD agrees to pay CONTRACTOR for services satisfactorily rendered pursuant to this Agreement. The 3. compensation under this Contract shall not exceed Fifty Thousand Dollars and 00/100

Dollars (\$50,000.00), at an hourly billing rate not to exceed N/A per hour. This sum shall be for full performance of this Agreement and includes all fees, costs, and expenses incurred by Contractor including, but not limited to, labor, materials,

taxes, profit, overhead, travel, insurance, subcontractor costs, and other costs.

If CONTRACTOR will be compensated hourly for services provided under this Contract. CONTRACTOR shall describe in Exhibit "A." attached hereto, the specific scope of services to be delivered on an hourly basis to OUSD.

OUSD shall not be liable to CONTRACTOR for any costs or expenses paid or incurred by CONTRACTOR in performing services for OUSD, except as follows: N/A

Notice shall be effective when received if personally served or, if mailed, three days after mailing. Either party must give written notice of a change of address.

8. Status of Contractor: This is not an employment contract. CONTRACTOR, in the performance of this Agreement, shall be and act as an independent contractor. CONTRACTOR understands and agrees that it and all of its employees shall not be considered officers, employees, agents, partner, or joint venture of OUSD, and are not entitled to benefits of any kind or nature normally provided employees of OUSD and/or to which OUSD's employees are normally entitled, including, but not limited to, State Unemployment Compensation or Worker's Compensation. CONTRACTOR shall assume full responsibility for payment of all Federal, State, and local taxes or contributions, including unemployment insurance, social security and income taxes with respect to CONTRACTOR's employees. In the performance of the work herein contemplated, CONTRACTOR is an independent contractor or business entity, with the sole authority for controlling and directing the performance of the details of the work, OUSD being interested only in the results obtained.

9. Insurance:

- 1. Unless specifically waived by OUSD, the following insurance is required:
 - i. If CONTRACTOR employs any person to perform work in connection with this Agreement, CONTRACTOR shall procure and maintain at all times during the performance of such work, Workers' Compensation Insurance in conformance with the laws of the State of California and Federal laws when applicable. Employers' Liability Insurance shall not be less than One Million Dollars (\$1,000,000) per accident or disease.

Check one of the boxes below:

- CONTRACTOR is aware of the provisions of Section 3700 of the Labor Code which require every employer to be insured against liability for workers' compensation or to undertake self-insurance in accordance with the provisions of that code, and will comply with such provisions before commencing the performance of the Work of this Contract.

- ii. The coverage shall be primary as to OUSD and shall name OUSD as an additional insured. Evidence of insurance must be attached. Endorsement of OUSD as an additional insured shall not affect OUSD's rights to any claim, demand, suit or judgment made, brought or recovered against CONTRACTOR. The policy shall protect CONTRACTOR and OUSD in the same manner as though each were separately issued. Nothing in said policy shall operate to increase the Insurer's liability as set forth in the policy beyond the amount or amounts shown or to which the Insurer would have been liable if only one interest were named as an insured.
- iii. If CONTRACTOR is offering OUSD professional advice under this Contract, CONTRACTOR shall maintain Errors and Omissions insurance or Professional Liability insurance with coverage limits of One Million Dollars (\$1,000,000) per claim.

OR

- iv. CONTRACTOR is not required to maintain any insurance under this agreement. (Completed and approved Waiver of Insurance Form is required from OUSD's Risk Management.) Waiver of insurance does not release CONTRACTOR from responsibility for any claim or demand.
- 10. Licenses and Permits: CONTRACTOR shall obtain and keep in force all licenses, permits, and certificates necessary for the performance of this Agreement.
- 11. **Assignment**: The obligations of CONTRACTOR under this Agreement shall not be assigned by CONTRACTOR without the express prior written consent of OUSD.
- 12. Non-Discrimination: It is the policy of OUSD that in connection with all work performed under Contracts there be no discrimination because of race, color, ancestry, national origin, religious creed, physical disability, medical condition, marital status, sexual orientation, gender, or age; therefore, CONTRACTOR agrees to comply with applicable Federal and California laws including, but not limited to, the California Fair Employment and Housing Act beginning with Government Code Section 12900 and Labor Code Section 1735 and OUSD policy. In addition, CONTRACTOR agrees to require like compliance by all its subcontractor(s). CONTRACTOR shall not engage in unlawful discrimination in employment on the basis of actual or perceived; race, color, national origin, ancestry, religion, age, marital status, pregnancy, physical or mental disability, medical condition, veteran status, gender, sex, sexual orientation, or other legally protected class.

- Drug-Free / Smoke Free Policy: No drugs, alcohol, and/or smoking are allowed at any time in any buildings and/or grounds on OUSD property. No students, staff, visitors, CONTRACTORS, or subcontractors are to use controlled substances, alcohol or tobacco on these sites.
- 14. **Indemnification**: CONTRACTOR agrees to hold harmless, indemnify, and defend OUSD and its officers, agents, and employees from any and all claims or losses accruing or resulting from injury, damage, or death of any person, firm, or corporation in connection with the performance of this Agreement. CONTRACTOR also agrees to hold harmless, indemnify, and defend OUSD and its elective board, officers, agents, and employees from any and all claims or losses incurred by any supplier, contractor, or subcontractor furnishing work, services, or materials to CONTRACTOR in connection with the performance of this Agreement. This provision survives termination of this Agreement.
- 15. Copyright/Trademark/Patent/Ownership: CONTRACTOR understands and agrees that all matters produced under this Agreement shall become the property of OUSD and cannot be used without OUSD's express written permission. OUSD shall have all right, title and interest in said matters, including the right to secure and maintain the copyright, trademark, and/or patent of said matter in the name of OUSD. CONTRACTOR consents to use of CONTRACTOR's name in conjunction with the sale, use, performance and distribution of the matters, for any purpose and in any medium. These matters include, without limitation, drawings, plans, specifications, studies, reports, memoranda, computation sheets, the contents of computer diskettes, artwork, copy, posters, billboards, photographs, videotapes, audiotapes, systems designs, software, reports, diagrams, surveys, source codes or any other original works of authorship, or other documents prepared by CONTRACTOR or its Sub-CONTRACTORs in connection with the Services performed under this Agreement. All works shall be works for hire as defined under Title 17 of the United States Code, and all copyrights in those works are the property of OUSD.
- 16. **Waiver**: No delay or omission by either party in exercising any right under this Agreement shall operate as a waiver of that or any other right or prevent a similar subsequent act from constituting a violation of the Agreement.
- 17. Termination: OUSD may at any time terminate this Agreement upon 30 days prior written notice to CONTRACTOR. OUSD shall compensate CONTRACTOR for services satisfactorily provided through the date of termination. In addition, OUSD may terminate this Agreement for cause should CONTRACTOR fail to perform any part of this Agreement. In the event of termination for cause, OUSD may secure the required services from another contractor. If the cost to OUSD exceeds the cost of providing the services pursuant to this Agreement, CONTRACTOR shall pay the additional cost.
- 18. **Conduct of CONTRACTOR**: By signing this Agreement, CONTRACTOR certifies compliance with the following requirements and will provide OUSD with evidence of staff qualifications, which include:
 - 1. **Tuberculosis Screening**: CONTRACTOR is required to screen employees who will be working at OUSD sites for more than six hours. CONTRACTOR affirms that each employee has current proof of negative TB testing on file and TB results are monitored.
 - 2. Fingerprinting of Employees and Agents. The fingerprinting and criminal background investigation requirements of Education Code section 45125.1 apply to CONTRACTOR's services under this Agreement and CONTRACTOR certifies its compliance with these provisions as follows: "CONTRACTOR certifies that CONTRACTOR has complied with the fingerprinting and criminal background investigation requirements of Education Code section 45125.1 with respect to all CONTRACTOR's employees, subcontractors, agents, and subcontractors' employees or agents ("Employees") regardless of whether those Employees are paid or unpaid, concurrently employed by OUSD, or acting as independent contractors of CONTRACTOR, who may have contact with OUSD pupils in the course of providing services pursuant to the Agreement, and the California Department of Justice has determined that none of those Employees has been convicted of a felony, as that term is defined in Education Code section 45122.1. Contractor further certifies that it has received and reviewed fingerprint results for each of its Employees and Contractor has requested and reviews subsequent arrest records for all Employees who may come into contact with OUSD pupils in providing services to the District under this Agreement."

In the event that OUSD, in its sole discretion, at any time during the term of this contract, desires the removal of any CONTRACTOR related persons, employee, representative or agent from an OUSD school site and, or property, CONTRACTOR shall immediately, upon receiving notice from OUSD of such desire, cause the removal of such person or persons.

- 19. No Rights in Third Parties: This Agreement does not create any rights in, or inure to the benefit of, any third party except as expressly provided herein.
- 20. **OUSD's Evaluation of CONTRACTOR and CONTRACTOR's Employees and/or Subcontractors**. OUSD may evaluate CONTRACTOR's work in any way that OUSD is entitled to do so pursuant to applicable law. The OUSD's evaluation may include, without limitation:
 - 1. Requesting that OUSD employee(s) evaluate the CONTRACTOR and the CONTRACTOR's employees and subcontractors and each of their performance.
 - 2. Announced and unannounced observance of CONTRACTOR, CONTRACTOR's employee(s), and/or subcontractor(s).
- 21. Limitation of OUSD Liability: Other than as provided in this Agreement, OUSD's financial obligations under this Agreement shall be limited to the payment of the compensation provided in this Agreement. Notwithstanding any other provision of this Agreement, in no event, shall OUSD be liable, regardless of whether any claim is based on contract or tort, for any special, consequential, indirect or incidental damages, including, but not limited to, lost profits or revenue, arising out of, or in connection with, this Agreement for the services performed in connection with this Agreement.
- 22. **Confidentiality**: CONTRACTOR and all CONTRACTOR's agents, personnel, employee(s), and/or subcontractor(s) shall maintain the confidentiality of all information received in the course of performing the Services. CONTRACTOR understands that student records are confidential and agrees to comply with all state and federal laws concerning the maintenance and disclosure of student records. This requirement to maintain confidentiality shall extend beyond the termination of this Agreement. Contractors will be permitted

access to student data only where permissible under state and federal law and only after executing OUSD's Confidentiality Agreement Regarding Student Data.

23. **Conflict of Interest**: CONTRACTOR shall abide by and be subject to all applicable, regulations, statutes or other laws regarding conflict of interest. CONTRACTOR shall not hire any officer or employee of OUSD to perform any service by this Agreement without the prior approval of OUSD Human Resources.

CONTRACTOR affirms to the best of his/her/its knowledge, there exists no actual or potential conflict of interest between CONTRACTOR's family, business or financial interest and the services provided under this Agreement, and in the event of change in either private interest or services under this Agreement, any question regarding possible conflict of interest which may arise as a result of such change will be brought to OUSD's attention in writing.

Through its execution of this Agreement, CONTRACTOR acknowledges that it is familiar with the provisions of section 1090 *et seq.* and section 87100 *et seq.* of the Government Code of the State of California, and certifies that it does not know of any facts which constitute a violation of said provisions. In the event CONTRACTOR receives any information subsequent to execution of this Agreement which might constitute a violation of said provisions, CONTRACTOR agrees it shall notify OUSD in writing.

- 24. Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion: CONTRACTOR certifies to the best of his/her/its knowledge and belief, that it and its principals are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from covered transactions by any Federal department or agency according to Federal Acquisition Regulation Subpart 9.4, and by signing this contract, certifies that this vendor does not appear on the Excluded Parties List (https://www.sam.gov/).
- 25. Litigation: This Agreement shall be performed in Oakland, California and is governed by the laws of the State of California, but without resort to California's principles and laws regarding conflict of laws. The Alameda County Superior Court shall have jurisdiction over any litigation initiated to enforce or interpret this Agreement.
- 26. **Incorporation of Recitals and Exhibits**: The Recitals and each exhibit attached hereto are hereby incorporated herein by reference. CONTRACTOR agrees that to the extent any recital or document incorporated herein conflicts with any term or provision of this Professional Services Contract, the terms and provisions of this Professional Services Contract shall govern.
- 27. Integration/Entire Agreement of Parties: This Agreement constitutes the entire agreement between the Parties and supersedes all prior discussions, negotiations, and agreements, whether oral or written. This Agreement may be amended or modified only by a written instrument executed by both Parties.
- 28. **Counterparts**: This Agreement and all amendments and supplements to it may be executed in counterparts, and all counterparts together shall be construed as one document.
- 29. **Signature Authority**: Each party has the full power and authority to enter into and perform this Agreement, and the person signing this Agreement on behalf of each Party has been given the proper authority and empowered to enter into this Agreement.
- 30. Contract Contingent on Governing Board Approval: OUSD shall not be bound by the terms of this Agreement until it has been formally approved by OUSD's Governing Board, and no payment shall be owed or made to CONTRACTOR absent that formal approval. This Agreement shall be deemed approved when it has been signed by the Board of Education, and/or the Superintendent as its designee.
- 31. **W-9 Form**: If CONTRACTOR is doing business with OUSD for the first time, complete and return with the signed Contract the W-9 form.
- 32. **Contract Publicly Posted**: This contract, its contents, and all incorporated documents are public documents and will be made available by OUSD to the public online via the Internet.

Dear OUSD:

The <u>TK Integrated Arts Learning Initiative</u> creates and sustains equitable and inspired learning experiences for students. Children in the earliest grades develop essential social-emotional and cognitive skills, impacting their level of readiness as they matriculate to Kindergarten and beyond. Initiated in early 2014, through a collaboration between OUSD, Oakland Rotary and Pro Arts, the Initiative provides on-site Artist Residencies facilitating art instruction in partnership with classroom teacher as a process for deepening student learning and creating collaborative learning environments, as well as leading professional development workshops for TK Teachers in arts integration.

Pro Arts will also provide four (4) professional development sessions for TK Teachers in arts integration during the 2017-18 school year. These professional development session with be offered to TK Teachers and document (video) for subsequent wider dissemination in support of STEAM advocacy efforts .

Equity: Visual Art education integrated curriculum in support of school readiness for children who otherwise have limited or no access to the arts.	October 2017 - May 2018	 Pro Arts will partner with 12 Elementary schools throughout the Oakland Unified School district to provide 13 visual art residencies for the benefit of students who live in designated "high-stress" areas. Teaching artists will work with TK students over the course of 18 sessions. Teaching artists will directly engage 300 students in the classroom. In addition, teaching artists will engage indirectly estimated 1000 students. This number includes students at each partner school site outside of the TK grade level who will see the exhibition of student artwork in the hallways and other shared spaces. Making Art Visible: Display student artwork in classrooms, school hallways, and public spaces throughout the school year.	October 2017 - May 2018	 Throughout the academic year, student artwork will be displayed within the classroom and hallways at partner schools. We estimate that each classroom will make a total of 18 art projects throughout the 18 sessions. With approximately 24 students in each classroom, this will result in the creation of 432 individual artworks per classroom and 5,184 artworks in total. Of this number, half of the art works will be displayed outside the classroom in school hallways and shared spaces allowing other elementary students, teachers, school administration, and family and school visitors to view and engage with the work. TK students from Martin Luther King Jr. Elementary will visit Pro Arts four times throughout the year on walking field trips. These visits exposed young students to contemporary art.
Sustainability: Increased demand and advocacy for Integrated Learning in Oakland schools as a pathway to excellence.	October 2017 - May 2018	 Curriculum developed in partnership between the teaching artist and classroom teacher continues to strengthen with each year of collaboration. Teaching artists are able to become more familiar with each classroom teacher's individual teaching style and their priorities for student learning. Pro Arts focuses on strengthened partnerships with principals to make STEAM learning a priority throughout the Oakland district. We continue to keep principals in the loop about what was taking place in the classroom to indicate the immediate effects art can have by encouraging creative expression and experimentation.

Section 5: Project Narrative

Pro Arts' model of art integration aims to develop the social-emotional and cognitive skills of TK students that are essential to student learning as they matriculate to Kindergarten and beyond. This programmatic focus aligns with the California statewide goal to support the development of early childhood learning. According to *A Resource for California Public School District Administrators and Teachers* (2013), there is a growing urgency for students to excel from a young age, "Because of the increasing academic demands placed on kindergarten students, there is less and less time to



nurture social and emotional skills. Deficiencies in these areas tend to inhibit learning in younger kindergarten students, which causes them to fall behind academically." The TK Learning Initiative Program prioritizes arts education to develop the school readiness for children who otherwise would have limited or no access to the arts. Art is often critical for those students to express feelings they have trouble otherwise vocalizing. When integrated in the curriculum, the visual arts provide opportunity for new social and emotional learning connections, as well as close the achievement and opportunity gap for those students.

To successfully integrate art into classroom learning, teaching artists develop curriculum to meet Common Core Standards and Visual and Performing Arts Content Standards (VAPA) for California Public Schools at the TK learning level. VAPA standards include 1.0 Artistic Perception, 2.0 Creative Expression, 3.0 Historical and Cultural Context, 4.0 Aesthetic Valuing and 5.0 Connections, Relationships and Applications.

Making Art Visible is another key component to the TK Learning Initiative Program. Teaching artists, classroom teachers and school principals work in unison at each partner school to engage the larger student population, parents and school visitors, through pop-up art exhibits, temporary projects and longer exhibitions, thus making art visible and reinforcing the importance of creative thinking and expression.

In addition to our commitment to early childhood education, Pro Arts provides diligent professional development for both teaching artists and classroom teachers in order to deepen student learning and create a collaborative learning environment. Teaching artists gain more experience as in-classroom educators and have the opportunity to develop an 18-week curriculum. In addition, TK classroom teachers become more familiar with arts integration as a method to connect students in new ways with other subjects including math and science. Pro Arts hosts teacher training and professional development workshops, introducing artistic practices to educators with an emphasis on the creation of dynamic, collaborative cultures of learning for teachers and students and the development of emergent curriculum through art. Teaching artists meet once a month as a cohort at Pro Arts. During these meetings, teaching artists articulate what lesson plans had been successful and why, as well as discuss specific areas of improvement. These meetings serve as key moments for reflection and knowledge exchange. As an additional resource for classroom teachers and the larger art education community, Pro Arts plans to produce four videos, serving as an open source professional development tool.

Sarah was one of the earliest leaders of the Oakland Art Murmur, and served as its Treasurer for the first 5 years. She also collaborated with other curators' projects, Neighborhood Public Radio and The Illuminated Corridor, to produce work at Southern Exposure, the Whitney Biennale, and in various public spaces in the Bay Area.

Warith Taha - Teaching Artist

Warith Taha is a mixed-media visual artist who believes strongly in art's power to foster understanding, build community and create change. An Oakland native, Taha has had the opportunity to work both here in the Bay Area and abroad to bring art to populations of traditionally underserved youth. Section 8: Project Evaluation Plan

At the end of each school year, Pro Arts utilizes both quantitative and qualitative methods in data interpretation in order to assess the success of the TK Learning Initiative Program. We requested feedback, which was provided by school principals, teaching artists and the students themselves in the form of surveys, questionnaires and long-form answers.

In addition and as part of the evaluation process, Pro Arts assesses if the artist residency influenced a change in the classroom teacher's approach to exploring STEAM curriculum in the future. To that extent, we survey both the teaching artist and the classroom teacher in the beginning and the end of our program. From the teaching artist perspective, Pro Arts assess the professional growth of each teaching artist and receives feedback on their experience as an educator.

Section 9: Sustainability Plan/Strategies

Moving into our final year of implementation of the TK Learning Initiative Program, our goal is to seek direct funding from partner schools as well as other foundations and corporate sponsors so we can continue to facilitate this important initiative. Artist residencies over the course of 18 sessions allow for visual art to become a key component of early childhood education. This time frame has been successful to not only develop collaborative relationships with principals and classroom teachers, but also understand the specific learning needs of each student.

Currently, outside of the support from our partners OUSD, Pro Arts receives funding towards our Youth Arts Education Program from The City of Oakland Cultural Funding Program (Art in Schools Program) and the Walter & Elise HAAS Fund. These funds are allocated to cover teaching artist fees, art supplies and administration of the program.
