#### **ACTION REQUESTED**

Approval by the Board of Education of Resolution No. 1718-0084 - Application for Provisional Internship Permit – California Commission on Teacher Credentialing – on behalf of the following employees for School Year 2017-2018:

- 1. Quiana Canada, 1st Grade, Fruitvale Elementary School;
- 2. Roger Clay, 2<sup>nd</sup> Grade, Markham Elementary School;
- 3. Eli Wise, K-12<sup>th</sup> Grade Music, Various Schools, including Melrose Leadership Academy;
- 4. Ana Harston, 9-12th Grade SDC Mild/Moderate, Oakland Tech.

### **BACKGROUND**

According to Title 5 Sections 80021-80021.1, the Provisional Internship Permit (PIP) was created in response to the phasing out of emergency permits and became effective on July 1, 2005. It allows an employing agency to hire an individual who has not yet met the subject matter competence requirement needed to enter an internship program. Prior to requesting a PIP, the employing agency must verify that a diligent search has been made, and a fully credentialed teacher cannot be found.

The PIP is only available at the request of an employing agency. Individuals may not apply directly to the Commission for this document. Holders of the PIP are restricted to service with the employing agency requesting the permit. An employing agency is defined as a California public school district, county office of education, non-public school, charter school, or statewide agency.

The PIP is available in the areas of Multiple Subject, Single Subject, and Education Specialist. Individuals who were issued four or fewer emergency permits may be issued one PIP as long as the employer requirements have been met. Individuals who were issued five emergency permits do not qualify for the PIP.

# **DISCUSSION**

The Board of Education, exercising the power of the Governing Board, may approve an application seeking a Provisional Internship Permit from the Commission on Teacher Credentialing, as may be necessary for certain certificated employees of the District so they may work in the District for the 2017-2018 school year, as follows:

The current request for the 2017-2018 school year, a Provisional Internship Permit is being sought for the following employee:

- 1. Quiana Canada, 1st Grade, Fruitvale Elementary School;
- 2. Roger Clay, 2<sup>nd</sup> Grade, Markham Elementary School;

- 3. Eli Wise, K-12th Grade Music, Various Schools, including Melrose Leadership Academy;

Quiana Canada graduated from Hampton University with a Bachelor's in Political Science. The Provisional Internship Permit will allow her time to complete the CSET exams and the requirements for a University Internship Multiple Subject: General Subjects teaching credential.

Roger Clay graduated from Morehouse College with a Bachelor's in Political Science. The Provisional Internship Permit will allow him time to complete the CSET exams and the requirements for a University Internship Multiple Subject: General Subjects teaching credential.

Eli Wise graduated from Wesleyan University with a Bachelor's in Music and Mills College with a Master's in Music Composition. The Provisional Internship Permit will allow him time to complete the CSET Exams and the requirements for a University Intern Single Subject: Music teaching credential.

Ana Harston graduated California State University, East Bay, with a Bachelor's in Sociology. The Provisional Internship Permit will allow her time to complete the CSET exams and the requirements for a University Internship Education Specialist Mild/Moderate teaching credential.
