Action Requested Approval by the Board of Education of the Side Letter of Agreement, as

Agreement between the District and UAOS concerning Voluntary Unpaid Leave and Voluntary Payroll Deductions. Form collection period will be December 15,

2017 through January 15, 2018.

Summary In order to address financial challenges for this 2017-18 fiscal year, Oakland

Unified School District ("District") must undergo mid-year budget adjustments.

On November 17, 2017, parties representing the District and UAOS reached an

agreement to offer the option of voluntary unpaid leave or payroll deductions to

UAOS members to help the District reduce 2017-18 costs.

Fiscal Impact An estimated cost savings to the District will be reported to the Board of

Education at a later date.

**Recommendation** Approval by the Board of Education of the Side Letter of Agreement, as

Agreement between the District and UAOS concerning Voluntary Unpaid Leave

#### SIDE LETTER OF AGREEMENT

# Voluntary Contributions and Voluntary Unpaid Leave between the

# United Administrators of Oakland Schools (UAOS) and the

#### Oakland Unified School District ("District")

This side letter agreement ("Agreement") is entered into between the United Administrators of Oakland Schools ("Union") and the Oakland Unified School District (the "District"). The purpose of the Agreement is to provide UAOS members with a mechanism for contributing, on a voluntary basis, to the District's effort to reduce payroll expenditures during the 2017-18 school year. Pursuant to this Agreement, UAOS members will have two voluntary options:

1) Unit members may donate on a voluntary basis through payroll deductions. 2) Unit members may elect to take voluntary unpaid leave.

#### Option 1: Voluntary Donations Through Payroll Deductions

- a) On a strictly voluntary basis, UAOS members may elect a voluntary after-tax contribution/donation equivalent to their gross daily rate or a flat dollar amount as determined by the UAOS member.
- b) Voluntary donations will be collected by an after-tax payroll deduction.
- c) Such donations may be classified as a charitable contribution.
- d) UAOS members who elect to donate days may not take time off as consideration for the deducted amount:
- e) UAOS members may elect to donate by completing the form in *Attachment 1: 2017-18 Voluntary Contribution Deduction Form* and submitting it to Labor Management and Employee Relations, 1000 Broadway, Suite 680, Oakland, CA 94607 by January 15, 2018.
- f) By January 30, 2018, each donating member will receive a letter of confirmation from the District confirming the amount of the deductions and the schedule for implementation of such deductions by payroll.

### Option 2: Voluntary Unpaid Leave

For the remainder of the 2017-18 school year, unit members will be allowed to choose up to five (5) days of voluntary unpaid leave.

- a) Unit members will elect this option by submitting a completed form including all unpaid leave to be taken for the year. (see Attachment 2: 2017-18 Voluntary Unpaid Leave Form).
- b) Effective December 15, 2017 and through January 15, 2018, Attachment 2: 2017-18 Voluntary Unpaid Leave Form may be submitted to the Labor Management and Employee Relations office, 1000 Broadway, Suite 680, Oakland, CA 94607. Forms must be submitted on or before January 15, 2018 at 5pm.

UAOS neither endorses or opposes voluntary contribution and/or voluntary unpaid leave. This is optional and a personal decision for each UAOS member.
