# **ACTION REQUESTED:**

Adoption by the Board of Education of Resolution No. 1718-0146 - Measure N - College and Career Readiness Commission Report - Education Improvement Plan (Linked Learning) - Probationary Status Schools Findings and Assessment To Date/Funding Recommendations - 2018-2019 School Year.

### **BACKGROUND:**

The Measure N Commission over the last year made selected visits to school sites, received monthly reports from its staff and held hearings on December 5, and 19, with schools, to determine progress made over the last five months in implementing Measure N. Consequently, based on established criteria applied fairly and equitably to each school site, progress made and status during the last year-two years and five months incorporated in each school sites assessment report, the Commission, as of January 16, 2018, designated a school as either Probationary Fully Implemented or Probationary Planning and Piloting regarding implementation of Measure N. A link to each school's Assessment is embedded in the Resolution.

Consequently, the Commission **unanimously** adopted and recommends the Board of Education approve, for 2018-2019, the "High School Education Improvement Plan Implementation Assessment Awards," approved by the Measure N Commission on January 16, 2018, as follows:

WHEREAS, the Oakland Unified School District ("District") Board of Education by Resolution Nos. 1415-0119 and 1415-0119A, has established, pursuant to the College and Career Readiness Act, the Measure N Commission, to oversee the Act including advising and reporting to the Board of Education and for (1) Planning, which includes (a) reviewing each high school's School Quality Review findings, Balanced Scorecard results, and education improvement plans, and (b) submitting school funding recommendations to the Board of Education for action; and (2) Oversight, which includes (a) oversight of proper allocation and use of all parcel tax monies, (b) reviewing annual independent audit reports, and (c) submitting recommendations to the Board of Education for any new or modified policies and administrative regulations to ensure the Oakland Unified School District's compliance with the requirements and intent of this Measure; and

**WHEREAS**, the Measure N – College and Career Readiness Oversight Commission, in its third year of operations, on December 5, 2017 received presentations, on December 19, 2017 discussed presentations and on January 16, 2018 made status findings and adopted funding recommendations for each high school named herein as stated and hereby recommends approval of same by the Board of Education,
