Prop. 39: Why does a district-run school have to share space with a charter-run school?

- Prop. 39 Law: Charter school students that live in Oakland are entitled to space (for their charter schools) at OUSD district-run schools.
- All Oakland residents, including parents of charter students, pay rent/property taxes that go towards OUSD facilities (including bonds).

The above reasons are why charter-run schools' <u>in-district ADA</u> (students that live in Oakland) are legally entitled to space in OUSD facilities.





Prop. 39: Does the charter-run school have to pay for the space at the district-run school?

Yes

- Charter-run schools <u>must pay their fair share</u> (prorata= \$3.85) for the space that they have exclusive use of (e.g. classrooms) and the space that they have partial use of (e.g. cafeteria, auditorium).
- Charter-run schools also pay their own <u>utilities</u>.
- In addition, the charter-run schools also have to pay for their share of the <u>salary/benefits of the</u> <u>custodial staff</u> if they are sharing a campus with a district-run school.





Prop. 39: How long are the leases under Prop. 39?



The Prop. 39 renews annually. Prop. 39 entitles the charter-run school to occupy the site for <u>one-year</u>. Therefore, at the end of the Prop. 39 one-year cycle, the charter-run school must re-apply for Prop. 39 and/or pursue other facilities options.









Prop. 39: Is out-of-District ADA considered in Prop. 39 allocation of space?

Though a charter-run school might have out-of-District students, Prop 39 allocations of space are based on the charter-run school's **in-District ADA** only.












Prop. 39: Number of Classrooms

2013 OUSD Law & Asset Management Policy

Treat all students attending publicly funded schools equitably

Primary Considerations



Space allocation – required classrooms (*teaching stations*), administration, specialized spaces



Location – proximity to desired location and/or students served



Grade level – compatibility of facility design to grades served



Unique program – specialized programmatic facility needs



Long-term need – consideration of school growth and expanded space needs



District gaps – consideration identified unmet needs

Prop. 39: Allocation of Space

A charter-run school's allocation of space, including specialized (e.g. science labs), and non-teaching space is determined by an analysis of comparison schools. A charter-run school must be allocated space that is reasonably equivalent to space existing at comparison schools.

The offer expectations are that a charter-run school co-located with a district-run school will share non-teaching space and, if necessary, specialized teaching space. This may or may not be possible depending upon the space configurations and the specialized spaces present/not present at the district facility being offered.

Therefore, a charter-run school may receive specialized teaching space in the form of exclusive use classrooms included in the offer.
