- B. Ensure that all CONTRACTOR personnel, including subcontractors, will comply with any policy and systems in place at OUSD and School(s). This includes, but is not limited to the following:

CONTRACTOR shall not hire any OUSD employee to perform the services in this MOU, and affirms that to the best of its knowledge no such conflict presently exists. CONTRACTOR agrees to alert OUSD in writing if and when a potential conflict arises.
- 4. Family Education Rights and Privacy Act—CONTRACTOR shall observe all District policies and regulations, and state and federal laws, including the Family Education Rights and Privacy Act of 1974, commonly known as FERPA, related to the confidentiality of pupil and personnel records.
- Tuberculosis Screening: CONTRACTOR is required to screen employees and agents who will be present at OUSD sites during the current school year.

 CONTRACTOR affirms that each person has current proof of negative TB testing on file and TB results are monitored. Please see Section IV for the relevant documentation that is required.
- D. Fingerprinting of Employees and Agents. E. Insurance

- 1. General Liability: EITHER (a) CONTRACTOR maintains general liability insurance that names OUSD as an additional insured, for operations, students, volunteers, and personnel at location where CONTRACTOR provides programs/services with at least \$1 Million in coverage, and furnish certificate of said insurance to OUSD OR (b) CONTRACTOR is not required to maintain general liability insurance under this agreement if the Risk Management Officer signs a waiver of insurance. STAGEBRIDGE

Scope of Work & Statement of Qualifications

Scope of work

Storybridge Listening & Speaking is a popular school residency program in which professional teaching artists and volunteer "grandparent mentors" guide students through a sequential curriculum focused on recording histories of family elders, creating stories based on these accounts, writing and shaping the stories, and then rehearsing and performing each story before an audience of peers and family members. Full residencies are 16 weeks, although schools may opt for shorter versions of the program. Storybridge has been proven by independent evaluations to enhance student literacy and writing skills; to help develop dramatic and expressive spoken skills; to strengthen self-confidence, self-esteem and comfort in public presentations; to promote cross-cultural understanding and mutual tolerance for the traditions and heritages of students and their peers; and to help create bonds between the generations, through interviews with family elders and classroom work with Stagebridge "grandparent mentors." 80% of current Storybridge residencies take place in the Oakland Unified School District.

Statement of qualifications

Stagebridge, the nation's oldest senior theatre company, is celebrating its 39th season. Based in Oakland since 1978, the company has always advanced its mission to enrich and transform the lives of seniors and their communities through the performing arts. At the time, there were few opportunities for older adults to express themselves creatively in the performing arts. Stagebridge began as an acting class at an Oakland senior center in 1978. Within a year a small company emerged of five women in their 70s wanting to express themselves and "shine in the spotlight." Initially, plays dealing with aspects of aging were created by the ensemble and toured senior centers. The senior audiences responded emotionally to seeing their peers on stage addressing important issues and presenting positive role models of aging. The company then took plays to elementary schools and found that the children were amazed to see people their great-grandparents' ages on stage, having fun and sharing their creativity. Stagebridge had found a unique niche which it has continued to develop with innovative creative programs for seniors, including intergenerational activities that continue to bring young and old together.

After nearly 40 years the goals and objectives of Stagebridge remains the same. Today, Stagebridge consists of nearly 300 students who range in age from 55-100 (average age 70), taught by two dozen of the Bay Area's best performing arts teaching artists. The theatre and storytelling program has trained several thousand seniors, many of whom have gone on to perform in various community settings, including professional theatre productions and independent films. Stagebridge has created nearly 40 plays that have been seen by more than 250,000 people. They concern such topics as street crime, depression, caregiving, stereotypes, love and sex, and epic local historic events like the Free Speech Movement at U.C. Berkeley in the 1960s.

All Stagebridge programs are tied directly to the mission "to enrich the lives of seniors and their communities through the performing arts." Our primary audiences are seniors and urban elementary school children. The core programs are:

- 1) Weekly ongoing professional fee-based theatre and storytelling classes held at our home at Arts First Oakland that are geared to older adults at all levels of experience, taught by some of the Bay Area's most talented artists. These classes comprise the Performing Arts Training Institute (PATI), which offers a comprehensive performing arts curriculum organized into three 12-week quarters and a shorter summer class program. PATI has quadrupled in scope and scale since 2007-2008; in 2016-17, Stagebridge offered 42 different classes for 292 unduplicated adults, some of whom enrolled in two or more classes. Class fees are kept affordable through funding from public andprivate agencies, and cost only about 35% as similar classes taught by the same artists at Berkeley Rep and other local theatres.

 2) "Seniors Reaching Out," a program that takes free subsidized acting, storytelling, music workshops and performances of original plays directly to nursing homes, senior centers, retirement homes and community sites. These are geared to people who don't have opportunities to see or participate in the performing arts. Seniors Reaching Out consists of a small group of trained storytellers and of six touring troupes that perform musical programs, improv and "Radio Plays," a revival of 1930s-style radio melodramas that is tailored to serve the needs of clients at Lighthouse for the Blind and similar agencies.
- 3) The "Storybridge Listening and Speaking" program in Title I Oakland and Richmond elementary schools. Storybridge offers 16-week class residencies with grandparent storytellers, professional storytelling teachers, assembly programs and performance opportunities to 2nd-5th grade classrooms in a sequential program; in 2016-2017, approximately 400 Oakland youth will directly benefit, and 2,200 of their peers will attend assemblies and performance related to the program. The "Grandparent Tales Writing Contest" encourages children to write stories about their grandparents, rewards all participants, and showcases the best stories on local cable TV and in public performances at local bookstores.

Stagebridge has earned a national reputation for its work. It has been featured on PBS, CNN and National Public Radio, and in The Huffington Post, the Wall Street Journal and other media outlets. The company is the only senior theatre ever to be funded by the NEA, and is currently featured by the NEA as a model program for "Best Practices" in the field of Aging & Creativity. From 2003-2006, and again in 2008-2012, the company was awarded prestigious multi-year grants from the U.S. Department of Education for their work in the Oakland schools. Stagebridge is regularly invited to perform or present around the nation, including at conferences of the Gerontological Society of America, the National Conference on Creativity and Aging and many others. In April 2016, Stagebridge was selected by the Administration for Community Living at the Department of Health and Human Services as the lead presenter at Laugh Lines, part of their Brain Health campaign, which was held in San Francisco. Stagebridge programs are offered in almost all Bay Area Counties; however, about 85% of all programming takes place in Oakland.
