Anti-Discrimination—It is the policy of OUSD that in connection with CONTRACTOR's services under this MOU there shall be no discrimination against any employee engaged in the work because of race, color, ancestry, national origin, religious creed, physical disability, medical condition, marital status, sexual orientation, gender, age, or other legally protected class. Therefore, the CONTRACTOR agrees to comply with all applicable Federal and California laws.
 - 3. **Conflict of Interest**—CONTRACTOR shall abide by and be subject to all applicable OUSD policies, regulations, statutes or other laws regarding conflict of interest. CONTRACTOR shall not hire any OUSD employee to perform the services in this MOU, and affirms that to the best of its knowledge no such conflict presently exists. CONTRACTOR agrees to alert OUSD in writing if and when a potential conflict arises.
 - 4. **Family Education Rights and Privacy Act**—CONTRACTOR shall observe all District policies and regulations, and state and federal laws, including the Family Education Rights and Privacy Act of 1974, commonly known as FERPA, related to the confidentiality of pupil and personnel records.
- C. **Tuberculosis Screening:** CONTRACTOR is required to screen employees and agents who will be present at OUSD sites during the current school year. CONTRACTOR affirms that each person has current proof of negative TB testing on file and TB results are monitored. Please see **Section IV** for the relevant documentation that is required.
- D. Fingerprinting of Employees and Agents. The fingerprinting and criminal background investigation requirements of Education Code section 45125.1 apply to CONTRACTOR's services under this MOU and CONTRACTOR certifies its compliance with these provisions as follows: "CONTRACTOR certifies that CONTRACTOR has complied with the fingerprinting and criminal background investigation requirements of Education Code section 45125.1 with respect to all CONTRACTOR's employees, subcontractors, agents, and subcontractors' employees or agents ("Employees") regardless of whether those Employees are paid or unpaid, concurrently employed by OUSD, or acting as independent contractors of CONTRACTOR, who may have contact with OUSD pupils in the

course of providing services pursuant to the MOU, and the California Department of Justice has determined that none of those Employees has been convicted of a felony, as that term is defined in Education Code section 45122.1. CONTRACTOR further certifies that it has received and reviewed fingerprint results for each of its Employees and CONTRACTOR has requested and reviews subsequent arrest records for all Employees who may come into contact with OUSD pupils in providing services to the District under this MOU. Please see Section IV for the relevant documentation that is required.

In the event that OUSD, in its sole discretion, at any time during the term of this MOU, desires the removal of any CONTRACTOR related person, employee, representative or agent from any OUSD school; site; and/or property, CONTRACTOR shall immediately, upon receiving notice from OUSD of such desire, cause the removal of such person or persons.

E. Insurance

- <u>General Liability: EITHER</u> (a) CONTRACTOR maintains general liability insurance that names OUSD as an additional insured, for operations, students, volunteers, and personnel at location where CONTRACTOR provides programs/services with at least \$1 Million in coverage, and furnish certificate of said insurance to OUSD OR (b) CONTRACTOR is not required to maintain general liability insurance under this MOU if the Risk Management Officer signs a waiver of insurance. Please see Section IV for the relevant documentation that is required.
- 2. Workers' Compensation: If CONTRACTOR employs any person to perform work in connection with this MOU, CONTRACTOR shall procure and maintain at all times during the performance of such work, Workers' Compensation Insurance in conformance with the laws of the State of California and federal laws, when applicable. The CONTRACTORS' Employers' Liability Insurance shall not be less than One Million Dollars (\$1,000,000) per accident or disease. SCOPE OF WORK: HIFY Programs at Oakland Unified School District:

SKILL (Sharing Knowledge to Increase Leadership & Learning): HIFY's expertise in HIV prevention programming for youth has enabled us to bring more than \$1.4 million in federal prevention funding over 5 years to local communities. We have adapted a nationally-recognized evidence-based curriculum into a dynamic, locally-appropriate sexual health education and substance abuse prevention program and are delivering it to a broad array of underserved youth locally. We address self-care, healthy relationships, trauma, and alcohol and drug use from a harm reduction framework so that young people understand how to better manage risks that increase their vulnerability. We connect youth with key local resources—including local clinics and HIV testing. We also provide training to teachers and youth-serving providers to help them support prevention efforts. Federal funds cover most, but not all, of the costs of delivering this multifaceted program.

Challenging the Stigma of Seeking Mental/Behavioral Health Help: HIFY received an innovation grant from Alameda County Behavioral Health Services to pilot a program challenging stigma related to help-seeking and providing help for mental/behavioral health challenges in three Oakland high schools. We are combining a youth-driven marketing campaign with a youth peer health education program to try to shift stigma around seeking help, and also around listening and providing support to peers. Such stigma is a barrier not only to seeking mental health services but also to pursuing mental health careers. Moreover, given the number of teens affected of anxiety, depression, and suicidal ideation, HIFY has recognized the importance of combining mental health first-aid approaches with our traditional behavioral health strategies.

Leadership in Diversity for LGBT Youth: HIFY delivered empowering programming at four underserved Oakland high schools/middle schools, helping to build an ecosystem of resources in communities where these young people have largely been invisible and at greater risk of negative health and academic outcomes. The program is organized in a 90-minute afterschool timeslot, once per week over 28 weeks at each school, and also includes an average of two hours of collective monthly activities that bring the youth together. The after-school curriculum includes content on LGBT history, culture, and activism, as well as self-care, substance use, and mental health. By helping youth understand how resistance to anti-LGBT bias and oppression created a vibrant LGBT community, we help them to understand their own experiences of bias/oppression and their own capacity for empowerment. They learn both self-care skills (including self-advocacy, decisionmaking, emotional management, and healthy relationship skills) and leadership/organizing skills. Youth put these leadership skills into action and gain valuable experience planning events and activities. They also have significant voice and choice in identifying the events/activities they want to undertake (e.g., a traditional "Day of Silence" or "Transgender Day of Remembrance" observation; tabling at a school or community event; or other relevant activity). We also organized our first ever summer intensive for LGBT youth, which was a great success.

STATEMENT OF QUALIFICATIONS

The mission of Health Initiatives for Youth (HIFY) is to improve the health and well-being of underserved young people through innovative youth leadership, popular education, and advocacy in the pursuit of multi-level social change. HIFY was founded in 1992 by a team of committed health care and youth service professionals in response to the immediate need for HIV prevention, treatment, and care for young people in San Francisco. We soon broadened our geography to the East Bay, and widened our focus to address an array of youth health issues from a youth development and social justice perspective. HIFY is widely respected throughout the Bay Area as a leading collaborative organization dedicated to improving youth health, and to enhancing the quality and scope of youth health and social service provision. HIFY works primarily in San Francisco and Alameda Counties, and prioritizes traditionally underserved youth, including low-income youth, youth of color, LGBT youth, and youth who live at the intersections of these identities.

We have a 25-year history of developing innovative programs and resources that have transformed the local culture of youth health education and contributed to meaningful improvements in health infrastructure for young people. HIFY has extensive experience participating in larger collaboratives and partnering with a range of health and youth-serving organizations and networks. For example:

- For 10 years, HIFY spearheaded and administered the Ryan White (Title IV)-funded Project AHEAD, a
 collaboration of HIV testing services and agencies that provided an integrated system of service for HIVpositive youth in San Francisco.
- With Mental Health Act funding, HIFY was contracted to provide cultural competency training to behavioral health professionals in San Francisco to improve their ability to work with transition-age youth and LGBTQ youth.
- HIFY worked to create youth health clinics at Lincoln and Washington High Schools. HIFY currently trains Youth Outreach Workers (YOWs) for the San Francisco Unified School District, and collaborates with schoolbased Wellness Centers.
- HIFY took a lead role in the collaborative that created Dimensions Clinic, the only clinic specifically for LGBTQ youth in San Francisco. HIFY was also its fiscal sponsor for many years.
- HIFY has participated actively in the San Francisco Adolescent Health Working Group (AHWG), which successfully pushed the San Francisco Department of Public Health (SFDPH) to establish an office of Adolescent Health. Through our involvement in AHWG, we played a key role in developing the San Francisco Unified School District's current *Be Real, Be Ready* health education curriculum.
- With support from the Oakland Fund for Children and Youth, we created the first "safe space" for LGBTQ youth in West Oakland.
- HIFY has received grants from the CDC, SAMHSA, Office of Minority Health for HIV prevention, sexual health
 education, and substance abuse prevention programs engaging youth in both Alameda and San Francisco
 Counties. HIFY has demonstrated year over year, statistically significant improvement in participants'
 substance abuse and HIV risk and strategy knowledge, awareness and behaviors, baseline to follow up.

In addition, HIFY has collaborated with countless local and regional youth-serving organizations and agencies, and provides technical assistance, support, and training services that have had a direct impact on the quality of youth care and service in this region. We are particularly known for trainings on youth and HIV, youth and substance use, working with LGBTQ youth, and health and youth development for providers in the San Francisco Bay Area.
