Subject School Governance Board Policy

Action Requested Approval of revisions to Board Policy 3625 School Governance

Background The District's School Governance Board Policy was adopted in April 2012 to empower

school site governance teams with expanded decision-making authority to address the specific needs of their students. The current Board Policy defines the school governance team as the School Site Council (SSC), and at most District schools, SSCs have a strong voice in crafting the Single Plan for Student Achievement (SPSA). However, two District Alternative Schools—Community Day Middle and High School and Gateway to College at Laney College—have consistently struggled to establish and maintain traditional SSCs

due to the structure of their programs.

To address these needs, a School Governance Working Group, composed of cross-departmental District staff and representatives of OUSD partner organizations, reviewed options and agreed upon a proposed amendment to Board Policy 3625 that would allow the Superintendent to grant select Alternative Schools permission to use an alternate school governance body as the Governance Team in lieu of a traditional School Site Council. This freedom would permit these schools to convene school governance bodies reflecting the unique makeup of their school communities.

The District's School Governance Board Policy was last updated in August 2013. The amendment before the Board today seeks to provide an option for an alternate school governance body to better meet the needs of specific schools where programmatic structures make it difficult to convene traditional School Site Councils. This will help to

ensure that all District schools have robust school governance teams in place.

This amendment does not change other elements of the current School Governance Board Policy, nor does it affect the mandate that every District school complete a Single Plan for Student Achievement (SPSA).
