Indemnification Agreement Between Bird Rides, Inc. and Oakland Unified School District

Indemnitee: Oakland Unified School District Agreement Date: October 19, 2018

Property: All of Indemnitee's sites identified in **Exhibit A** attached hereto

This Indemnification Agreement ("Agreement") is entered into as of this Agreement Date by Indemnitee and Bird Rides, Inc., a Delaware corporation ("Bird").

AGREEMENT

- 1) <u>Property Operations</u>. Indemnitee owns or controls the Property, and hereby acknowledges and understands that in connection with Bird's operation of an electric scooter rental business, Bird's customers may from time to time operate Bird scooters around the Property.
- Indemnification. Bird agrees to indemnify, defend and hold harmless Indemnitee (and Indemnitee's employees, agents and affiliates) from and against all actions, damages or claims brought against Indemnitee to the extent of the negligence or willful misconduct of Bird, its employees, agents, affiliates and customers, except to the extent of Indemnitee's (or Indemnitee's employees', agents' or affiliates') negligence or willful misconduct. Indemnitee expressly acknowledges that in no event shall Bird be liable for any special, indirect, consequential or punitive damages. Bird's indemnification obligations shall survive for a period of one (1) year after expiration of the Term. Indemnitee's right to indemnification shall be contingent on Indemnitee notifying Bird promptly following receipt or notice of any claim; Indemnitee shall not consent to the entry of a judgment or enter into any settlement as to Bird without the prior written consent of Bird.
- 3) <u>Term; Termination</u>. The term of this Agreement shall be one (1) year following the Agreement Date ("<u>Term</u>"). The Term shall automatically renew for additional one (1) year periods unless either party gives written notice to the other at least thirty (30) days prior to the expiration of the then current Term of its intention not to renew.
- 4) <u>Notices</u>. All notices and communications between Indemnitee and Bird shall be made in writing (including electronic communications) and sent to the address below the applicable signature block.

5) <u>Miscellaneous</u>.

a) This Agreement shall be governed by the internal laws of the State of California without reference to any choice or conflict of law provision or rule. Except as specifically set forth herein, nothing herein shall be construed to confer any rights on any person other than Indemnitee and Bird and their respective successors and assigns. This Agreement may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement, and may be delivered by facsimile, .pdf format or other means of electronic transmission. This Agreement contains the entire agreement and understanding between Indemnitee and Bird and may not be amended except in writing and signed by both parties.

b) This Agreement is not an employment or partnership agreement. Each party, in the performance of this Agreement, shall be and act as an independent contractor and separate entity from the other. Each party understands and agrees that it and all of its employees shall not be considered officers, employees, agents, partners, or joint ventures of the other party, and is not entitled to benefits of any kind or nature normally provided employees of each of the respective parties and/or to which each of the respective party's employees are normally entitled, including, but not limited to, State Unemployment Compensation or Worker's Compensation.
