Roots Closure & CCPA Expansion in 2019-20

- Close Roots 6-8 Grades
- Expand CCPA 6th Grade Begin expansion of CCPA in the 6th grade and expand a grade level for the next seven years












Roots Rising 7th and 8th Grade Households



Priority Placement for Rising 7th and 8th Graders

- Before February 20, staff will contact families to provide "choice counseling" and school recommendations
- Family engagement will be ongoing until the end of February
- The Office of Enrollment will individually place students in schools based on anticipated seat availability and choice
- All rising Roots 7th and 8th graders will be priority placed before the general lottery to secure their spots in their next schools.









Action Plan for Placement

Case and Care Management

- The objective of care management is to facilitate a 1-to-1 "Choice Counseling" process with families who will be impacted by a Roots/CCPA closure and expansion.
- Given the historically low demand rate for Roots, this is an opportunity to support and build capacity in families to learn about and take advantage of a prioritized placement at a higher academically performing program.
- Model the options process for when students will be later engaged for high school options









Action Plan for Placement

Case and Care Management

- Choice Counseling will include 1-to-1 consultation;
 - Inquiry into family needs/wants for a potential next school
 - Overview of programs that match stated interests and preferences
 - Proximity
 - Performance
 - Enrichments
 - Information around support offerings
 - Transportation
 - Counseling
 - Family grouping











Closer Look at the Neighborhood

Within the Roots / CCPA / Greenleaf Attendance Boundary:

- 102 Roots rising 7th and 8th graders students have neighborhood priority to CCPA / Greenleaf
- SOL is nearby and does not have an attendance boundary
- 8 students with special needs requiring special day class (SDC) service for mild/moderate disabilities. Students can be supported by CCPA as it will take on these SDC classes.
- Currently connecting with families and resources to explore schools in other attendance areas.

Special Education Population for CCPA and Roots










Current Roots 6th & 7th Grade Special Ed

18 of 19 special education students at Roots are shown on the map. One student (not shown) lives outside of Oakland.




19 students with disabilities at Roots in Grades 6 & 7

 The highest level of service received by students with disabilities at Roots is Level 1, or mild/moderate disability. Roots does not operate any moderate/severe (Level 2) classes presently.



Of these 19 students, 6 or 32% are Latino and 13 or 68% are African American.

Students with Disabilities (Grades 6-8)



- Roots currently has 35 students with disabilities in grades 6-8 receiving resource services or who are in mild-moderate Special Day Classes.
- CCPA currently has 44 students with disabilities in grades 6-8 (21% of enrollment).
 The school operates resource and inclusion programs, as well as two 6-12th grade moderate-severe Special Day Classes.


The cohort graduation rate for Special Education students at CCPA in 2017-18 was 100%. In the last three years, 0 Special Education students dropped out. Compare this to the 61.9% district-wide graduation rate for Special Education students and the 11.3% dropout rate. In each of the three years shown, CCPA greatly outperformed the district.

Special Education Students CCPA


Pathway Participation

In 2018-19, 89.5% of Special Education students at CCPA were enrolled in Linked Learning Pathways vs. 73.4% districtwide. In each of the three years shown, Pathway participation for Special Education students was signficantly greater at CCPA.

School Demographics and Academic Performance










Race/Ethnicity (Grades 6-8)







The graduation rate for African American students at CCPA in 2017-18 was 100%. In the last four years 0 African American students dropped out. This is in comparison to a districtwide average graduation rate for African American students of 75%. In each of the three years shown, the rate was higher for CCPA than the district average.

African American Students CCPA



42.9% of African American students at CCPA met A-G requirements in 2017-18 vs. 29.1% districtwide. In each of the three years shown, the % of African American students at CCPA who met A-G exceeded that districtwide for African American students.
