The Public Hearing will be held June 26, 2019, at 7:30 p.m., or soon thereafter as the matter may be heard, in the Great Room, LaEscuelita Education Center, 1050 2nd Avenue, Oakland, CA 94606-2212.

The purpose of the Public Hearing is to take comments from the Redwood Heights School Community and from the Public regarding the District's proposed Application for above-stated Waiver, which, if granted, will relieve the District of the fiscal penalties - \$598.924.00 - associated with the Audit finding that insufficient instructional minutes were offered at Redwood Heights Elementary School during School year 2017-2018.
