#### Resolution No. 1920-0168

DIRECTING FACILITIES COMMITTEEE TO CONSIDER AND MAKE RECOMMENDATIONS TO THE GOVERNING BOARD AS TO WHETHER SAID BOARD SHALL UNDERTAKE THE PLANNING STEPS NECESSARY TO ULTIMATELY CALL A FACILITIES GENERAL OBLIGATION BOND ELECTION AND/OR A PARCEL TAX ELECTION FOR FACILITES MAINTENANCE IN NOVEMBER 2020

**WHEREAS**, the Oakland Unified School District (OUSD) values and endeavors to provide attractive, modern, and appropriate learning environments for all students; and

WHEREAS, it is estimated the District has \$2 billion in needs for facilities upgrades at present; and

WHEREAS, the current facilities bond funding will be depleted in 2020; and

**WHEREAS**, the Governing Board values the capital projects program and seeks to sustain it beyond 2020,

**NOW, THEREFORE, BE IT RESOLVED,** the Governing Board intends to pursue a General Obligation Bond Measure in November of 2020; and

**BE IT FURTHER RESOLVED**, the Board directs the Facilities Committee to bring final Bond Measure language, including amount sought, and a Facilities Master to the Board for approval no later than May of 2020; and

**BE IT FURTHER RESOLVED**, that the Board hereby directs the Facilities Committee to seek input from the Measures A, B, and J Independent Citizens' School Facilities Bond Oversight Committee on the language of the potential Bond Measure, prior to Facilities Committee recommendation and Board adoption; and

**BE IT FURTHER RESOLVED**, that the Facilities Committee shall recommend to the full Board the Facilities Master Plan and Bond Measure language; and

**BE IT FURTHER RESOLVED**, the Facilities Committee, concurrently, shall explore the feasibility of a companion Parcel Tax Measure to create a stable funding source for building maintenance, and make a recommendation to the Board on whether to place such a Measure on the November 2020 ballot.
