Subject: **Measure N Recommendations for 2018-19 Carryover Funds**
Date: October 31, 2019

OVERVIEW & OBJECTIVE

Twenty-one OUSD district schools and charter schools submitted their 2018-19 Measure N Carryover Justification Form that articulate the context that contributed to the carryover, the amount of carryover, the percentage of Measure N funds that are being carried over, and a clear budget for the carryover funds.

Seventeen of the schools, both district and charter, have carryover funds that are ten percent or more than the Measure N funds received. Per Measure N Commission policy, these seventeen schools require direct Measure N commission approval of the carryover justification form. Four of the schools, both district and charter, have carryover funds that are less than ten percent of the Measure N funds received.

Linked Learning High School Office staff have reviewed the 2018-19 Measure N Carryover Justification Forms and provided feedback to school sites that was addressed.
