BACKGROUND:

Since July 1994, the Commission on Teacher Credentialing has had the authority to issue waiver documents that have expressly to do with educator preparation and credentialing and with the ability of employers to employ or assign persons who are not appropriately credentialed for their assignment. All other waivers are under the legal authority of the State Board of Education or the Superintendent of Public Instruction.

A Waiver is issued or denied based upon the Commission's established criteria and factors such as an employer's continuing needs; the support the employer will provide to the applicant; or extenuating, extraordinary and unanticipated circumstances.

When an employing agency reviews its staffing needs and starts recruiting for various positions, all attempts must be made to fill a position with an appropriately credentialed employee. Employing agencies are required to first recruit a candidate who is qualified to participate in and enrolls in an approved internship program in the region of the employing agency and secondly, a candidate who is scheduled to complete preliminary credential requirements within six months.

If a fully credentialed candidate is not available employing agencies must recruit candidates in this order:

- A candidate who is scheduled to complete his or her preliminary credential requirements within six months
- A candidate who is qualified to participate and to enroll in an internship program
- A candidate who qualifies to use a local assignment option
- A candidate who qualifies for the Provisional Internship Permit (PIP) or the Short Term Staff Permit (STSP)

If the employer is unable to find an individual who qualifies for one of the staffing options listed above, the Variable Term Waiver may be requested for the most qualified candidate.

DISCUSSION:

The Board of Education, as the Governing Board, may approve an application seeking a Variable Term Waiver, from the Commission on Teacher Credentialing, as may be necessary for certain certificated employees of the District. For the 2019-2020 school year, CBEST, BCLAD and Program waivers are being sought for the following employees:

- 1. Manuel Flores is requesting a Variable Term CBEST Waiver. He graduated from UC, Santa Barbara with a Bachelors in Sociology. This waiver will allow candidate time to complete CBEST, CSET, and enroll in the Intern Program.
- 2. Claudia Leon is requesting a Variable Term CBEST Waiver. She graduated from CSU, Northridge with a Bachelors in Psychology. This waiver will allow candidate time to complete CBEST, CSET, and enroll in the Intern Program.
- 3. Leonardo Garza is requesting a Variable Term BCLAD Waiver. He graduated from CSU, East Bay with a Bachelors in Economics. This waiver will allow candidate time to complete CSET, and enroll in the Intern Program.
- 4. Aresha Dinkins is requesting a Variable Term CBEST Waiver. She graduated from CSU, East Bay with a Bachelors in Sociology. This waiver will allow candidate time to complete CSET, and enroll in the Intern

Program.

- 5. Jeniel Collins is requesting a Subsequent Variable Term CBEST Multiple Subject waiver. Jeniel graduated from Huston-Tillotson University, with a Bachelor's in Education. This waiver will allow candidate time to complete CBEST, CSET, and enroll in an Intern program.
- 6. Jared Crayton-Thomas is requesting an Administrative Waiver. This waiver will allow him to complete his program requirements for a Preliminary Administrative Services Credential in July 2020 with California State University, East Bay.
- 7. Israel Cisneros is requesting a Variable Term BCLAD: Spanish waiver. Israel graduated from San Francisco State University with a Bachelor's in English (Creative Writing). This waiver will allow candidate time to complete the CSET Exams required for a Full Bilingual Authorization: Spanish.
