# Connection to Citywide Plan: Key Strategy

---

**Key Strategy 2:** Update the existing Board Policy on Enrollment to

1. prioritize access to quality for students coming from school consolidations (Opportunity Ticket), and
2. revisit the priority ranking to ensure more equity in access to quality schools.

# Current Enrollment Policy: Priority Ranking

---

- Continuing Student priority
- Sibling priority
- Opportunity Ticket priority
- Neighborhood School priority
- School Staff priority
- Oakland Resident priority

# Recent Updates to Enrollment Board Policy

---

Timeline	Update
March 2019	Priority for Opportunity Ticket added
August 2018	Priority for students with IEPs added
August 2018	Dual Language policy created
August 2018	Priority for school staff added
October 2017	Priority for Oakland residents added

# Context: Data Review

# Tensions in Considering Enrollment Policies

---

- Neighborhood schools vs diverse schools (if there is residential segregation)
  - Related challenge around transportation
- Diversity that reflects the whole district vs diversity that reflects the neighborhood
- Feeder pattern predictability vs wider choice options
- Distribution and support of highest needs students vs concentration of services
- Diversity targeting one characteristic (e.g., socioeconomic) vs diversity across many characteristics (e.g., disability status, socioeconomic, race)

# Enrollment Policy Ideas from Other Cities

## Looking at Diversity

---

Mechanism	Goal of Mechanism
Diverse by Design Schools	Individual schools have greater diversity
Pro-Diversity Priorities or Set-Asides	Equitable access to high-demand schools
Weighted Lotteries	Equitable access to high-demand schools
Controlled Choice	School assignment plan to address diversity (limits choice)

*Note: There are multiple ways to implement each of these mechanisms, depending on the goals of the enrollment system.*

Guiding principle	Does our system accomplish the following?
Quality	<ul style="list-style-type: none"><li>● Improve academic outcomes across student groups</li><li>● Provide specialized programs of interest to families</li></ul>
Equity	<ul style="list-style-type: none"><li>● Reduce racial isolation within and between schools</li><li>● Support students with different needs, including students with disabilities and English Learners</li><li>● Provide tools for families to make informed choices</li></ul>
Sustainability	<ul style="list-style-type: none"><li>● Promote fiscal sustainability and program viability within each school and across the district</li></ul>

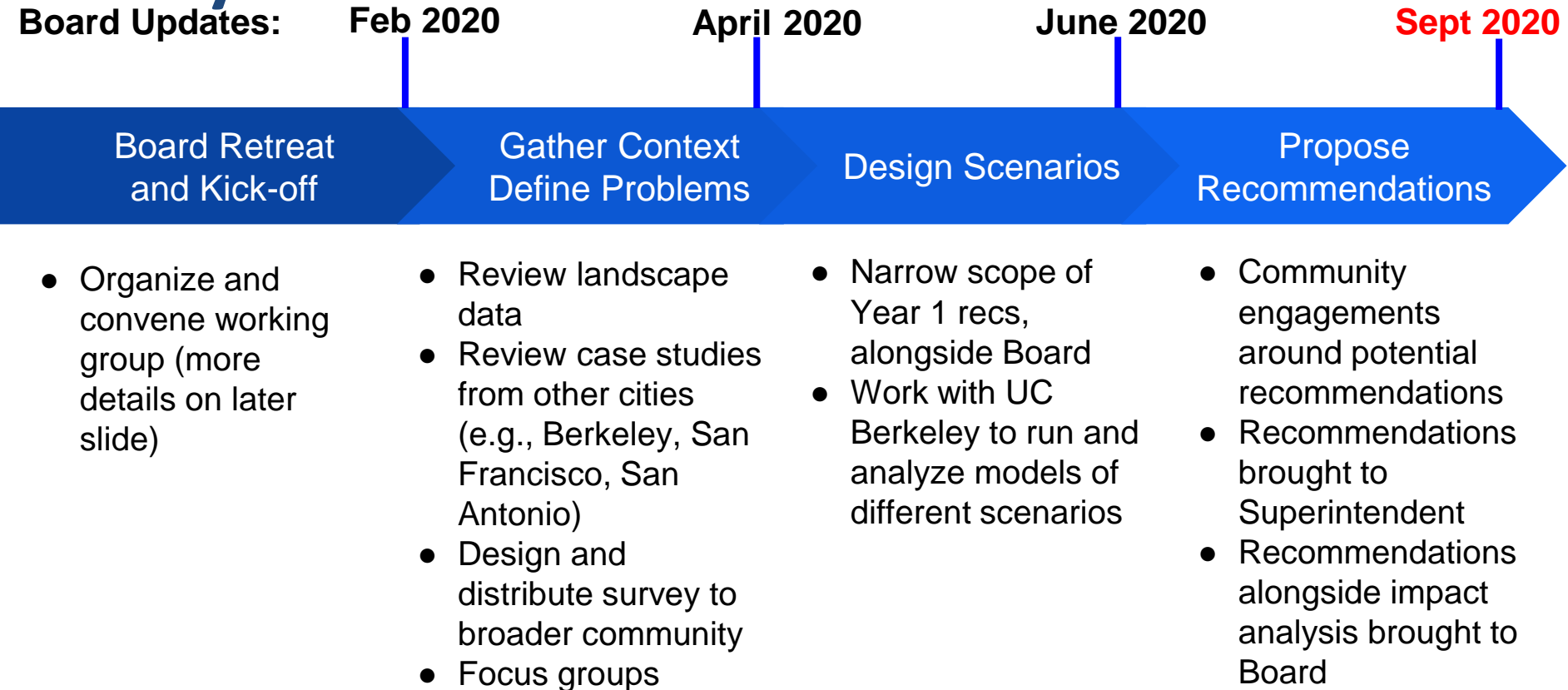
