**BACKGROUND**

Annually the District identifies and honors its own, and OUSD's Classified School Employees of the Year program aligns with the criteria used by the State of California Classified School Employees of the Year program.

The purpose is to recognize and pay special tribute to the tireless efforts and outstanding performance of one experienced classified line employee in each of six categories: Child Nutrition; Maintenance, Operations and Facilities; Office and Technical; Para-Educator and Instructional Assistance; School Security and Support; and Transportation. The District's six honorees are in turn submitted to the Alameda County Office of Education in consideration of state Classified School Employees of the Year.

As Superintendent, the Classified School Employees of the Year Selection Team has recommended to me that Lawana Wyatt, Tanya Chatman, Rodolfo Perez, Diana So, Jacqueline Simon and William Taylor, Jr., each, be recognized by the Board of Education as OUSD Classified School Employees of the Year for 2019-2020. 
