Foster Youth Advisory Committee

Highlights from the May 28 Meeting

- 1. Staff from the Alameda County Office of Education (ACOE), Beyond Emancipation/Independent Living Program (BE/ILP), and Alive Students shared how they could help provide some limited continuity of support for OUSD foster students after the elimination of OUSD foster youth case managers.
- 2. The service plans, staff numbers, and funding levels of these organizational partners limit the support that they are able to provide. For example, one of the partner organizations can only serve 11th and 12th graders. The OUSD Foster Youth case managers were already collaborating with ACOE and BE/ILP to support students. At this point, they are redoubling their efforts to meet the need. They will share data and collaborate more closely with the OUSD coordinator to prioritize students that need the most support.
- 3. FYAC is requesting a contract for that the laid off and experienced OUSD FY case managers to train the school-based and other case managers, as well as to provide careful transition to other providers.
- 4. FYAC remains committed to reinstating the Foster Youth Case Managers. We must win stronger mandates to protect services focused on the unique needs of foster students. Other OUSD services are not of the kind that can follow this very mobile student population, integrate other foster youth service providers, develop supportive relationships within and across schools, among other capacities.
