SUBJECT: Amendment of Layoffs/Additions/Net of Classified Positions for Fiscal Year 2020-2021

ACTION REQUESTED:

Adoption by the Board of Education of Resolution No. 1920-2026B - Amendment of Layoffs/Additions/Net of Classified Positions for Fiscal Year 2020-2021 ("Resolution"), which provides for the reduction or layoff of classified positions, and reinstatement, increase, or creation of authorized classified positions based on lack of funds and/or program need as reflected through the Budget Development process for 2020-2021.

DISCUSSION:

The Board, on April 7, 2020 (Legislative File Number 20-0692, Enacted No. 20-0484) and May 27, 2020 (Legislative File Number 20-1177) approved the reduction or layoff of certain classified positions based on lack of funds and/or lack of work.

The Board is requested to approve the Resolution, which provides for the reduction or layoff of classified positions, and reinstatement, increase, or creation of authorized classified positions based on lack of funds and/or program need as reflected through the Budget Development process for 2020-2021. The total effect of this resolution is to decrease the overall number of authorized classified positions by -63 full time equivalent ("FTE").

FISCAL IMPACT: For the 2020-2021 fiscal year, the net fiscal impact is dependent on the specific salary and benefit costs of those positions eliminated or reduced and those positions reinstated, increased, or created.

RECOMMENDATION:

Adoption by the Board of Education of Resolution No. 1920-2026B – Amendment, Layoffs/Additions/Net of Classified Positions for Fiscal Year 2020-2021 – providing for the reduction of layoff of classified positions, and reinstatement, increase, or creation of authorized classified positions based on lack of funds and/or program need as reflected through the Budget Development process for 2020-2021 Fiscal Year.

RESOLUTION OF THE BOARD OF EDUCATION OF THE OAKLAND UNIFIED SCHOOL DISTRICT Resolution No. 1920-2026B

Amendment of Layoffs/Additions/Net of Classified Positions for Fiscal Year 2020-2021 -

WHEREAS, the District, impacted by the anticipated loss of revenue from the federal government and facing increased costs, must reduce its expenses in Fiscal Year 2020-2021 and ensure that expenditures are aligned with the District's Strategic Plan and budget priorities; and

WHEREAS, the primary mission of the District is to educate its early childhood, K-12 pupils with the annual resources, revenues at its disposal; and

WHEREAS, for Fiscal Year 2020-2021, based on an anticipated lack of funds and shifts in work to increase efficiencies, it is necessary for the District to streamline, reorganize, reduce and/or eliminate positions, in whole or in part; and

WHEREAS, Education Code Sections 45101, 45114, 45117, 45298 and 45308 require action by the Board of Education if services for classified staff are in good faith to be reduced or eliminated in order to permit the layoff of classified employees due to lack of funds and/or program need, and

WHEREAS, The Board, on April 7, 2020 (Legislative File Number 20-0692 Enacted No. 20-0484) and May 27, 2020 (Legislative File Number 20-1177) approved the reduction or layoff of certain classified positions based on lack of funds and/or lack of work.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby determines that the particular kinds of classified services or positions labeled in the column "Elimination" in Exhibit C, attached and incorporated herein by reference as though fully set forth, shall be and hereby are eliminated due to lack of funds and/or lack of work effective 11:59 p.m., June 30, 2020; and 11:39 p.m., December 31, 2020, as indicated by Exhibit C.

BE IT FURTHER RESOLVED, that the Board of Education directs the Superintendent of Schools or her designee to reinstate and add the particular kinds of classified services or positions labeled in the columns "Reinstated" and "Add," respectively, in Exhibit C, attached and incorporated herein by reference as though fully set forth; and

BE IT FURTHER RESOLVED, that the Board of Education authorizes the Superintendent of Schools or her designee to: (1) send appropriate notices to all classified employees whose positions are lost, reduced, or otherwise impacted by the foregoing elimination of positions; and (2) to take all proper steps pursuant to Education Code Sections 45117 and 45308 to effectuate the Resolution; and

BE IT FURTHER RESOLVED, in approving the foregoing Resolve clauses of this Resolution, the Board of Education intends that the position results labeled in the column "Grant Total" in Exhibit C attached and incorporated herein by reference as though fully set forth, be achieved.
