SECTION 2: GRANT PURPOSE AND EXPECTED OUTCOMES

It is mutually understood that this grant is awarded with the expectation that you will expend the entire amount to address the following agreed-upon purpose and objectives. This grant is restricted and can only be used for the stated purpose and outcomes in this agreement. PURPOSE OF THIS GRANT

The purpose of the grant is to support the Computer Academy Director's salary during the 2019-2020 academic year, in alignment with the objectives of the Intel Project.

STEPS YOU WILL TAKE TO ACHIEVE YOUR RESULTS

Mr. Emmanuel Onyeador(\$70,000): This funding covers .75 FTE for the Computer Academy Director. The Pathway Director is responsible for:

- 1. STUDENT SUPPORT: Serve as the point of contact for pathway-wide systems to address students' academic and personal problems including but not limited to tutoring, bridging students to counselors such as the Student Support Specialist; Create a Pathway-wide system for advising students about work based learning opportunities, post-graduation options, and helping seniors apply for college and/or work.
- 2. COLLEGE & COMMUNITY PARTNERSHIPS: Maintain working relationships with Intel Partnership representatives and serve as the main point of contact for partnership open items. The Pathway Director will also be the main point of contact and lead for: Intel's Mentoring Program and Summer Internship Program, Academy wide Work Based Learning and the academy's advisory board
- 3. INTEL OAKLAND TECH BUDGET: Monitor funding and spending of Intel grant to ensure that all expenditures are in alignment with grant objectives, Pathway goals and student achievement.
- 4. COMPLIANCE & REPORTING: Submission of all documentation to Intel and the Oakland Public Education Fund including (NOTE: Any information going to Intel must be anonymised. No personal student information can be shared with Intel Corporation)
- 5. INTERNSHIPS: Coordinate planning and oversee the mentor & internship programs in partnership with the Project Manager at Intel; Secure internships for students including, but limited to Intel Summer Internship Program, UC Berkeley's IT Rotational Program etc.; Collaborate with Work Based Learning Liaison and the High School Linked Learning Work Based Learning teams to identify amd market internship and apprenticeship programs Computer Academy students are eligible for.

- 6. RECRUITMENT: Support student recruitment & selection from 8th through 10th grade via assemblies, classroom visits, middle school visits and creation of Pathway specific events such as the Girls at Tech Day; Coordinate juniors and seniors to help in the recruitment and orientation of new students.
- 7. COMMUNICATIONS & PUBLIC RELATIONS: Maintain continual communication with administrators / counselor to ensure that scheduling is done properly, including cohort scheduling for students and a common prep period for teachers; Serve as a liaison between Intel, the Oakland Public Education Fund district office, the school administration, and the Pathway teaching team.
- 8. LOGISTICS: Be the "project leader" for Pathway field trips—including career exploration visits, college visits, motivational activities, senior retreat, etc; Complete field trip forms and follow-up with school and district administrators to ensure that all field trip regulations are met. Secure staff or teacher chaperones for field trips.' Plan, organize, and implement special activities (e.g., recruitment events, graduation events, summer events)

WHAT WILL CHANGE AS A RESULT OF YOUR PROJECT

The grant will support the efforts of Mr. Emmanuel Onyeador, the Computer Academy Director at Oakland Technical HS, to coordinate planning, manage and execute programs for students, primarily historically underrepresented in technology roles (ie: Black/African American, Latinx/ Hispanic, women). Some of the outcomes associated with the programs and role's responsibilities include:

- Increase enrollment and retention of historically underrepresented groups in the Computer Academy
 Increase in Work Based Learning (WBL) opportunities and engagement for Computer Academy students to gain exposure into computer science academic and professional career paths
- Primary liaison and manager of after school tutoring program
- Increased STEM interest among Computer Science Academy students

SECTION 3: REPORTING REQUIREMENTS

The report(s) required to be submitted by Grantee to the Ed Fund pursuant to this section shall contain sufficient information to establish that all grant funds were used for the Grant Purposes in furtherance of the Ed Fund's exempt purposes. Grantee shall keep a record of all receipts and expenditures relating to the Grant for four years and make records available to the Ed Fund, if the Ed Fund so request, at reasonable times for review and audit. For grants with multiple disbursements, the amount of any payment subsequent to the initial payment may be modified to reflect restrictions and conditions met in the grant purpose and expected outcomes section of this agreement. Conditional grants are paid only after a condition has been met.

SECTION 5: GRANT AGREEMENT

This grant was solicited using the 501(c)(3) designation of the Oakland Public Education Fund (the Ed Fund). Therefore, the Ed Fund is obligated to serve as the fiscal sponsor for these funds and as such has a unique role in ensuring that these charitable funds are expended in ways that align with applicable state and federal laws, I.R.S. Codes, and funder intent.

On August 21, 2019, the Oakland Public Education Fund decided that financial support of the project described in the cover letter accompanying this agreement will further the Ed Fund's tax-exempt purposes. Therefore, the Ed Fund has created a restricted fund designated for such a project and has decided to grant all amounts that it may deposit to that fund, less any administrative charge as set forth below, to Regrant (Grantee), subject to the following terms and conditions:

- 1. If not already on file, grantee shall provide the Ed Fund with its governing documents, a completed and filed IRS Form SS4, an IRS Tax Determination Letter which shows proof of 501(c)(3) status, a Tax Form W9, or other documentation satisfactory to the Ed Fund, showing Grantee's separate existence as an organization.
- 2. Grantee shall use the grant solely for the project described in this agreement, and Grantee shall repay to the Ed Fund any portion of the amount granted which is not used for that project. Any changes in the purpose for which grant funds are spent must be approved in writing to the Ed Fund before implementation. The Ed Fund retains the right, if Grantee breaches this Agreement, or if Grantee's conduct of the project jeopardizes the Ed Fund's legal or tax status, to withhold, withdraw, or demand immediate return of grant funds, and to spend such funds so as to accomplish the purposes of the project as nearly as possible within the Ed Fund's sole judgment. Any tangible or intangible property, including copyrights, obtained or created by Grantee as part of this project shall remain the property of Grantee.
- 3. An administrative charge has been deducted from the originating grant. Such fees, interest, and charges are necessary to compensate the Ed Fund for its services administering the funds, and thus become unrestricted rather than restricted assets when paid.
- 4. Nothing in this Agreement shall constitute the naming of Grantee as an agent or legal representative of the Ed Fund for any purpose whatsoever except as specifically and to the extent set forth herein. This Agreement shall not be deemed to create any relationship of agency, partnership, or joint venture between the parties hereto, and Grantee shall make no such representation to anyone.
- 5. Grantee shall submit full and complete reports to the Ed Fund in compliance with Section 3 of this agreement. The report shall describe the charitable programs conducted by the Grantee with the aid of this grant.
- 6. Grantee shall ensure that the Ed Fund is included in any communications connected with the grant including press releases, programs, announcements, invitations, stories in the media, annual reports, and newsletters. Grantee will submit copies of any such publication with project report(s). Finally, Grantee will ensure that any mention of the Ed Fund on all printed material shall read: 'Project Name' has been made possible (in part) by the sponsorship of the Oakland Public Education Fund, with funding provided by (funders)" or an alternate credit to be agreed upon between you and the Ed Fund.
- 7. This grant is not to be used in any attempt to influence legislation within the meaning of Internal Revenue Code (IRC) Section 501(c)(3). No agreement, oral or written, to that effect has been made between the Ed Fund and Grantee
- 8. Grantee shall not use any portion of the funds granted herein to participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office, to induce or encourage violations of law or public





- policy, to cause any private inurement or improper private benefit to occur, nor to take any other action inconsistent with IRC Section 501(c)(3).
- 9. Grantee shall notify the Ed Fund immediately of any change in (a) Grantee's legal or tax status, and (b) Grantee's executive or key staff responsible for achieving the grant purposes.
- 10. In the event of any controversy, claim, or dispute between the parties arising out of or related to this Agreement, or the alleged breach thereof, shall be determined by arbitration in Alameda County, CA, before one arbitrator. The arbitration shall be administered by Judicial Arbitration and Mediation Services (JAMS) pursuant to its Streamlined Arbitration Rules and Procedures. Judgment on the award may be entered in any court having jurisdiction. This clause shall not preclude parties from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction. The prevailing party shall, in addition to any other relief, be entitled to recover its reasonable attorneys' fees and costs of sustaining its position. Each provision of this Agreement shall be separately enforceable, and the invalidity of one provision shall not affect the validity or enforceability of any other provision. This Agreement shall be interpreted and construed in accordance with the laws of the State of California applicable to contracts to be performed entirely within such State. Time is of the essence of this Agreement and of each and every provision hereof. The failure of the Ed Fund to exercise any of its rights under this Agreement shall not be deemed a waiver of such rights.
- 11. This Agreement shall be governed by and construed in accordance with the laws of the State of California applicable to agreements made and to be performed entirely within such State.

This Agreement constitutes the only agreement, and supersedes all prior agreements and understandings, both written and oral, among the parties with respect to the subject matter hereof. All Exhibits hereto are a material part of this Agreement and are incorporated by reference. This Agreement, including any Exhibits hereto, may not be amended or modified, except in a writing signed by all parties to this Agreement.
