## **ACTION REQUESTED:**

Approval by the Board of Education of Resolution No. 2021-0057 - Application for Variable Term Program Waiver – CBEST, BCLAD and Program - California Commission on Teacher Credentialing – Named Employees for School Year 2020-2021:

- 1. Luis Arroyo-Rodriguez, K 5<sup>th</sup> Grade Specialist Moderate/Severe, Howard Elementary;
- 2. Kei-Che Randle, K 5<sup>th</sup> Grade Deaf/Hard of Hearing, Glenview Elementary;
- 3. Leyder Chapman, 6<sup>th</sup> 8<sup>th</sup> Grade Physical Education, Frick/SOL Middle; and
- 4. Anabel Rizo-Gomez, 6<sup>th</sup> 8<sup>th</sup> Grade Spanish, Frick/SOL Middle.

## **BACKGROUND:**

Since July 1994, the Commission on Teacher Credentialing has had the authority to issue waiver documents that have expressly to do with educator preparation and credentialing and with the ability of employers to employ or assign persons who are not appropriately credentialed for their assignment. All other waivers are under the legal authority of the State Board of Education or the Superintendent of Public Instruction.

A Waiver is issued or denied based upon the Commission's established criteria and factors such as an employer's continuing needs; the support the employer will provide to the applicant; or extenuating, extraordinary and unanticipated circumstances.

When an employing agency reviews its staffing needs and starts recruiting for various positions, all attempts must be made to fill a position with an appropriately credentialed employee. Employing agencies are required to first recruit a candidate who is qualified to participate in and enrolls in an approved internship program in the region of the employing agency and secondly, a candidate who is scheduled to complete preliminary credential requirements within six months.

If a fully credentialed candidate is not available employing agencies must recruit candidates in this order:

- A candidate who is scheduled to complete his or her preliminary credential requirements within six months
- A candidate who is qualified to participate and to enroll in an internship program
- A candidate who qualifies to use a local assignment option
- A candidate who qualifies for the Provisional Internship Permit (PIP) or the Short Term Staff Permit (STSP)

If the employer is unable to find an individual who qualifies for one of the staffing options listed above, the Variable Term Waiver may be requested for the most qualified candidate.

### **DISCUSSION:**

The Board of Education, as the Governing Board, may approve an application seeking a Variable Term Waiver, from the Commission on Teacher Credentialing, as may be necessary for certain certificated employees of the District. For the 2020-2021 school year, CBEST, BCLAD and Program waivers are being sought for the following employees:

- 1. Luis Arroyo-Rodriguez is requesting a Variable Term CBEST Waiver. He graduated from UC Santa Cruz with a Bachelor in Sociology. This waiver will allow candidate time to complete CBEST, CSET exams and the requirements for a University Internship Education Specialist Mod/Sev teaching credential..
- 2. Kei-Che Randle is requesting a Variable Term Education Specialist Instruction. She graduated from University of Northern Iowa with a Bachelor in Public Health. This waiver will allow candidate time to complete CBEST, CSET exams and the requirements for a University Internship Education Specialist teaching credential.
- 3. Leyder Chapman is requesting a Variable Term CBEST Waiver due to health restrictions of COVID-19. He graduated from Instituto Superior de Cultura Fisica Manuel Fajardo with a Bachelor in Physical Education. This waiver will allow candidate time to complete CBEST, CSET and enroll in an Intern Program..
- 4. Anabel Rizo-Gomez is requesting a Variable Term BCLAD Waiver. She graduated from California Department of Education Translation with a Bachelors in Spanish Education. This waiver will allow candidate time to complete CSET Exams required for a Full Bilingual Authorization: Spanish.
